Subject: Freedom of Information Act (FOIA) Request 2021-002372WS

This is an Air Traffic Organization (ATO), Mission Support Services, Western Service Center (WSC), partial denial, partial no records response to your FOIA request dated January 4, 2021, made under the provisions of Title 5 United States Code (U.S.C), Section 552. You subsequently narrowed the scope of your FOIA request on March 17, 2021. You requested copies of Air Traffic Services data from any Federal Aviation Administration (FAA) Air Traffic Control facility related to an unidentified flying object on December 29, 2020, near Honolulu, Hawaii.

A search for records was conducted by the Honolulu Control Facility. This search revealed the following records responsive to your request which have been saved to the enclosed compact disc:

One redacted copy of the Mandatory Occurrence Report on December 29, 2020.

We have withheld information under Exemption 6 of the FOIA, Title 5 U.S.C. Section 552 (b)(6) that protects personally identifiable information which, if released, would cause a unwarranted invasion of personal privacy. We have determined that the personal privacy interests involved outweigh any public interest in the release of this information. The withheld information consists of personnel names and personal cell phone numbers, which have been clearly marked on the enclosed records.

There were no records responsive to your request, which sought audio re-recordings and radar data, because your request was received outside of the 45 day record retention period and this incident was classified as a 45-day file. The FAA retention and destruction regulations are outlined in FAA Order 7210.3BB, Facility Operation and Administration.

Your request qualifies for the "Media" fee category, whereby you are not charged for search time, any review time, and the first 100 pages of documents. There were no fees incurred in processing your request. An invoice is enclosed for your reference.
