Dear Mr. Greenewald:

This letter is in response to your Freedom of Information Act (FOIA) request, reference number **DEVCOM GVSC FOIA FA-23-0015** (formerly FA-23-0214) dated January 4, 2022, wherein you requested copies of "ALL records generated during the processing of FOIA request DEVCOM GVSC FOIA FA-21-0064... This would include, but not be limited to, all FOIA case processing notes; all internal communications including emails, letters and memos; all inter-agency communications including emails, letters and memos; and all other records that were generated during the processing of this request. I ask that you include a search for records of all levels of classification, including records that were transmitted using the SIPR, NIPR and JWICS systems." (original FOIA request enclosed).

Combat Capabilities Development Command (DEVCOM) Ground Vehicle Systems Center (GVSC) was able to locate 143 pages of email records pertaining to your request (enclosed). We determined portions of the records are exempt from disclosure under Title 5 U.S.C. § 552(b)(5) ("Exemption 5") and (b)(6) ("Exemption 6"). Exemption 5 protects from disclosure privileged communications within or between agencies, including those protected by deliberative process privilege. Exemption 6 and Department of Defense policy protects personnel from unwarranted invasion of personal privacy. We removed the phone numbers and email addresses of personnel who are not general officers, are not division chiefs, who do not normally work with the general public, or who are not federal employees.

Pursuant to 5 U.S.C. § 552(a)(8)(A)(i), the responsive records were analyzed for release determination while applying a presumption of openness to consider all disclosure determinations with transparency in mind and assessing any foreseeable harm considerations to ensure disclosure does not harm an interest protected by an exemption or is prohibited by law.

This decision is made as an initial determination only. If you would like to appeal this determination, please notify this office and include your case number, a copy of this letter, and a written statement addressing the basis for disagreement. Your appeal should address the information denied in this response and cannot be used to make a request for new or additional information. After review, this office will forward your appeal to the Army General Counsel, the designated Army Freedom of Information Act appellate authority. To

meet the deadline for appeal, your appeal correspondence must be received by this office within ninety (90) days of the date of this letter or the date this letter was sent to you. Thank you much for your patience while I was away last week. I was able to get from the team a brief statement describing the testing challenges during COVID:

“Lab availability and testing schedules were both intermittent during the height of the COVID-19 pandemic; in many cases, our health protection measures meant that travel was limited to mission-critical purposes only for which CRADA testing doesn’t qualify. As a result, when travel was restricted, testing was not possible. Overall since the beginning of the CRADA, we’ve successfully executed some tests, and those details and results, if releasable upon conclusion of the CRADA, will be available then.”
