PROPAGANDA WITH REGIONAL IMPLICATIONS, AMPLIFYING MODERATE VOICES WITHIN THE REGION, AND DRIVING AN IDEOLOGICAL WEDGE TO DISRUPT THE ENEMY NARRATIVE. THESE ACTIVITIES WILL BE COORDINATED BY A COMMUNICATION WORKING GROUP (CWG), CONSISTING OF REPRESENTATIVES FROM CCJ3-IO, CCPA, CCJ3-O, CCJ3-IATF, CCJ5-SC, CCJ2-OSINT, CCJ2-PLANS, CCJA, AND OTHER AGENCIES AS REQUIRED. THE CWG WILL PROVIDE COURSE OF ACTION RECOMMENDATIONS TO CDRCENTCOM VIA THE J3 AND DIRECTOR OF COMMUNCATIONS. STAFF SECTIONS AND SUBORDINATE COMMANDS WILL USE ORGANIC CAPABILITIES AND/OR COORDINATE WITH THE INTERAGENCY TO ACHIEVE OEV OBJECTIVES, WHILE ENSURING ALL OAA BEGIN WITH DETERMINING THE DESIRED INFORMATION EFFECT.
