E. SESSION SUMMARY:

Various unidentified objects (pgs 2 & 3). First set consists of a group of beige & white, rippled, flatter disc-shaped object which overlap each other. The second object feels mechanical and a part of a larger "machine". The third set consists of a series of tube-like structures in a ~~general~~ jumbled mess.

A thick liquid is leaking & dripping over a stack of objects which appear to be pots & pans. A location with metal shelves & metal clothes locker is important.

Phonetics include WAKA.... & WAKIA LUNA. India, Indonesia, New Guinea & Papua New Guinea are important. This vessel has links with India/Sri Lanka <sup>via</sup> ~~to~~ Indonesia.

There is the concept of "contorted" figures or objects. There are hundreds of red bags containing vegies or fruits-like objects. White fog or mist is coming off of metal. There <sup>is</sup> small, black pebbly-looking material present.

Numerous silver "cans" with a distinctive label (see pg 4 & 5) are present. The "cans" are 6"-8" high & about 6" in diameter. The label consists of a central figure, <sup>(maybe green)</sup> winged & with a mythological connection on a mustard yellow background. This, is turned, is outlined in a band of red, then one of white.

There is a sand-dust-like material w/ these cans. Round, ~~long~~ cylindrical containers are within this "sand-dust". These containers hold pieces of a whitish material; some are shaped, others uniformly sliced like a sausage. Some have a green leafy material in them.

There are also flat slabs reminiscent of ~~the~~ plaster board w/ the paper stacked into bundles.

Several times throughout this session the concepts of small, shaped objects & the feeling of <sup>stone</sup> "jade" or ivory occurred. However, these were both AOC or AIs.

The vessel is currently sailing parallel to a coral reef or atoll & is running more north than east. This location is historically a treacherous area for ships to sail in.
