1. (S/NF/SK) Monitor Tasking: Refer to original tasking package.


2. (S/NF/SK) Source Tasking: The Source was informed that this session would begin a new project. Source was then directed to begin by drawing a time line inclusive of the dates 6 Sep - 12 Sep and then to label the time line with the coordinates provided. (A spontaneous ideogram decoded into a water gestalt). Source was then specifically instructed to search the time line for an event or events keyed directly to the coordinates provided. This procedure was repeated twice more, for 13 -19 Sep and 20 - 26 Sep time lines.

3. (S/NF/SK) Summary: Source's summary and post-session work are attached.

4. (S/NF/SK) Comments: Source perceived that the event was similar to what had been described in an earlier session for the same time period; Source asked the monitor about this. Monitor responded that the geographical area was the same but that a different class of event was implied in the tasking. During the post-session application of dowsing techniques to the problem, the Source made the assumption that

SG1A were again the principle element of the task. Upon reviewing Source's work, the monitor corrected the Source and reiterated that the tasking for this problem was different than that for the previous, similar, project.


SESSION SUMMARY

SESSION: 31 AUG 87, 1023-1122 hrs

STARTING OFF IN STAGE VI, WITH A TIME-LINE AND COORDINATE, HAD THE IMMEDIATE IMPRESSION OF WATER OR LIQUID. SEARCHING THE TIME LINE FROM 6 SEP 87 THROUGH 12 SEP 87, COULD FIND NOTHING OF SIGNIFICANCE. FROM 13SEP 87 THROUGH 19 SEP 87, SOME GORT OF EVENT TAKES PLACE AROUND THE 15th. THE ONLY INFORMATION TO COME THROUGH WAS AN IMPRESSION OF A TALL CYLINDRICAL OBJET THE HAD SOMETHING LIKE A COLLAR, OR A PLATFORM NEAR THE TOP. THERE WAS ALSO SOMETHING FLASHING, (ADL-LIKE A STROBE LIGHT).






