SUMMARY OF INFORMATION

The phonetics included with the call sign are Felidan, Hagan/Haman and Narsaw. The call sign is directly associated with three drug men. The boat itself is common, with a big motor, and resembles a river boat. It makes a chimes sound. The current location of the vessel is 17°N-74°W which is south of Haiti in the Caribbean Sea. the final destination of the vessel is 27°N-82°W above Tampa Florida in the Gulf of Mexico. The vessel will be carrying illegal drugs in the form of cocaine.

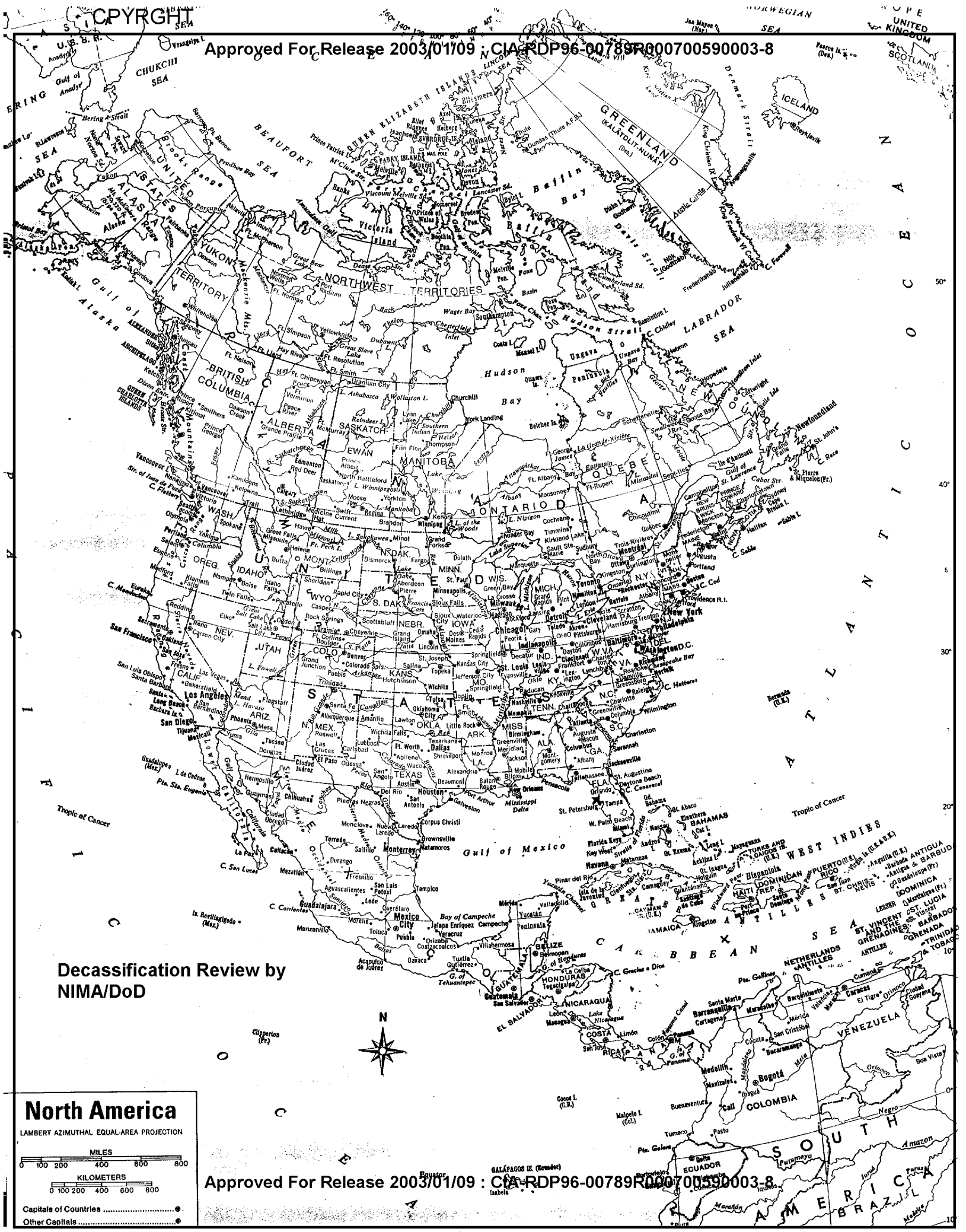

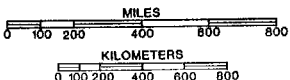
