SUMMARY OF INFORMATION

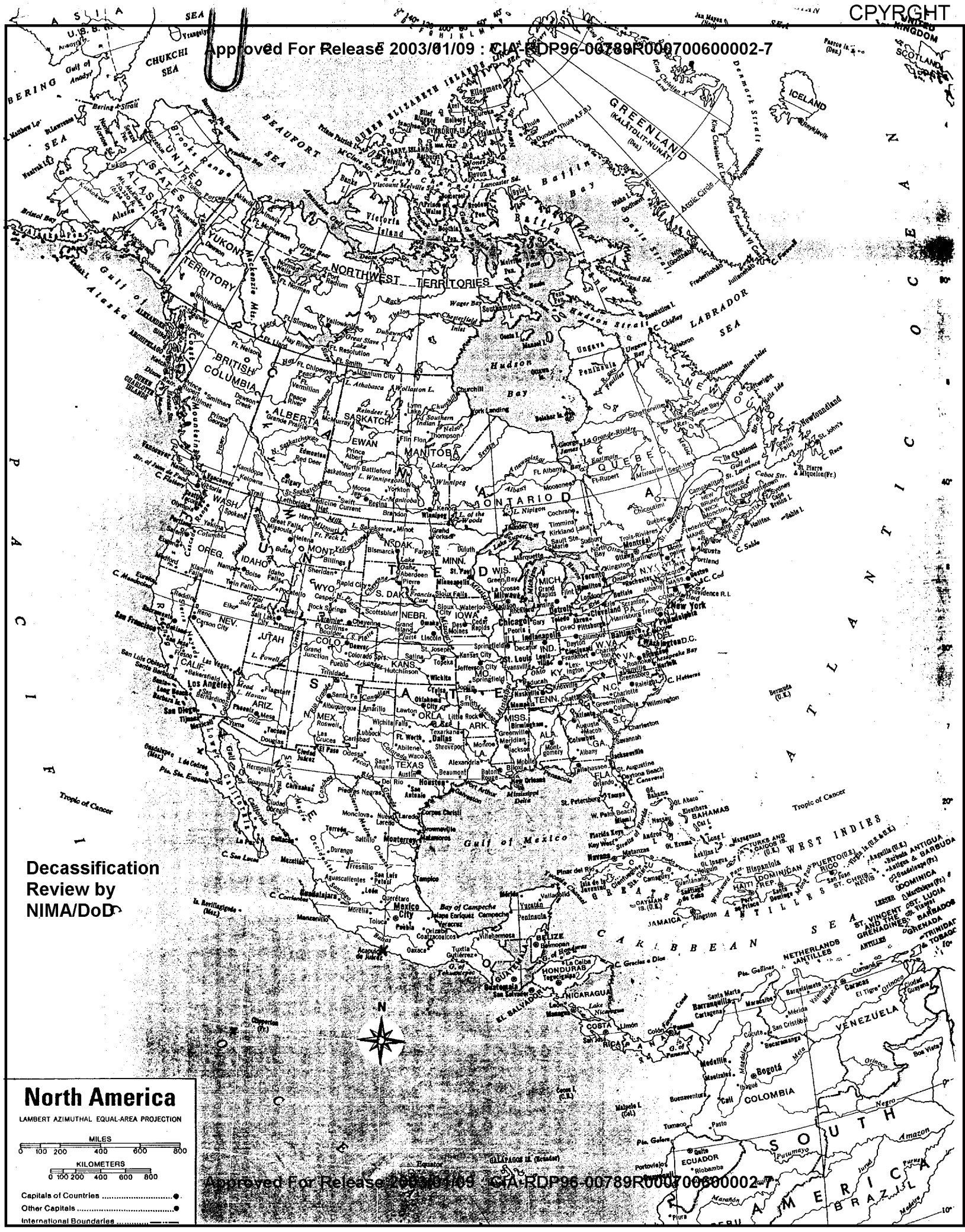

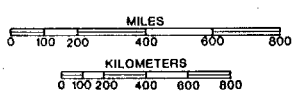
