> 1. (S/STD/NF) On 21 April 1990, three remote viewers conducted sessions against the suspected drug smuggling vessel known as departed Barranguilla, Colombia, o/a 1 May 1990 en-route for the Netherlands Antilles (Located

> directly north of Venezuela). The suspected load of contraband in the form of illegal drugs, is believed to be destined for the US.

(S/STD/NF) Viewer 095 reported that the vessel is currently focated north of Aruba at 1456N/70W and is moving slowly on a heading of 338 degrees. The vessel is carrying 8-10 kilograms of secarite. The cocaine is wrapped in several layers of waterproof material in a "metal bubble" welded in place on the port-side of the vessel, near the bow, several feet below the waterline. The contraband will be off-loaded/transferred in approximately 8 days (29 May) between 2100-2400L at night at a location west of Haiti at <u>18N/7450W</u>. The destination of the contraband in the US is The name "keye-yah", "kiya" phonetically outh of Florida. surfaced in connection with the vessel.

Liewer 003 reported that the vessel is moving in з. (S/STD/NF) a north-northwest direction at 1405N/6155W, about 60 miles WNW of t. Lucia Island. The vessel has a fish smell and a quantity of slimy crustaceans aboard. The people aboard the vessel feel safe and secure. The vessel is not at risk now. It recently carried contraband in the form of narcotics. It successfully unloaded the material and moved on. A search indicated that the contraband was recently off-loaded; it is projected for the US in the vicinity of 2530N/8030W at the Florida coast SE of Florida City.

(S/STD/NF) Viewer 018 reported that the current location of 4. the target vessel as of 1330 hrs on 21 May 90 is #505N/62W. There are no illegal drugs presently aboard ship. The goods just delivered were a white, acrid-tasting powder and were wrapped in plastic packages, which were approximately 2 inches by 10 inches

5. (S/STD/NF) There is correlation on the current location of the target vessel as reported by Viewer 003 and Viewer 018.
