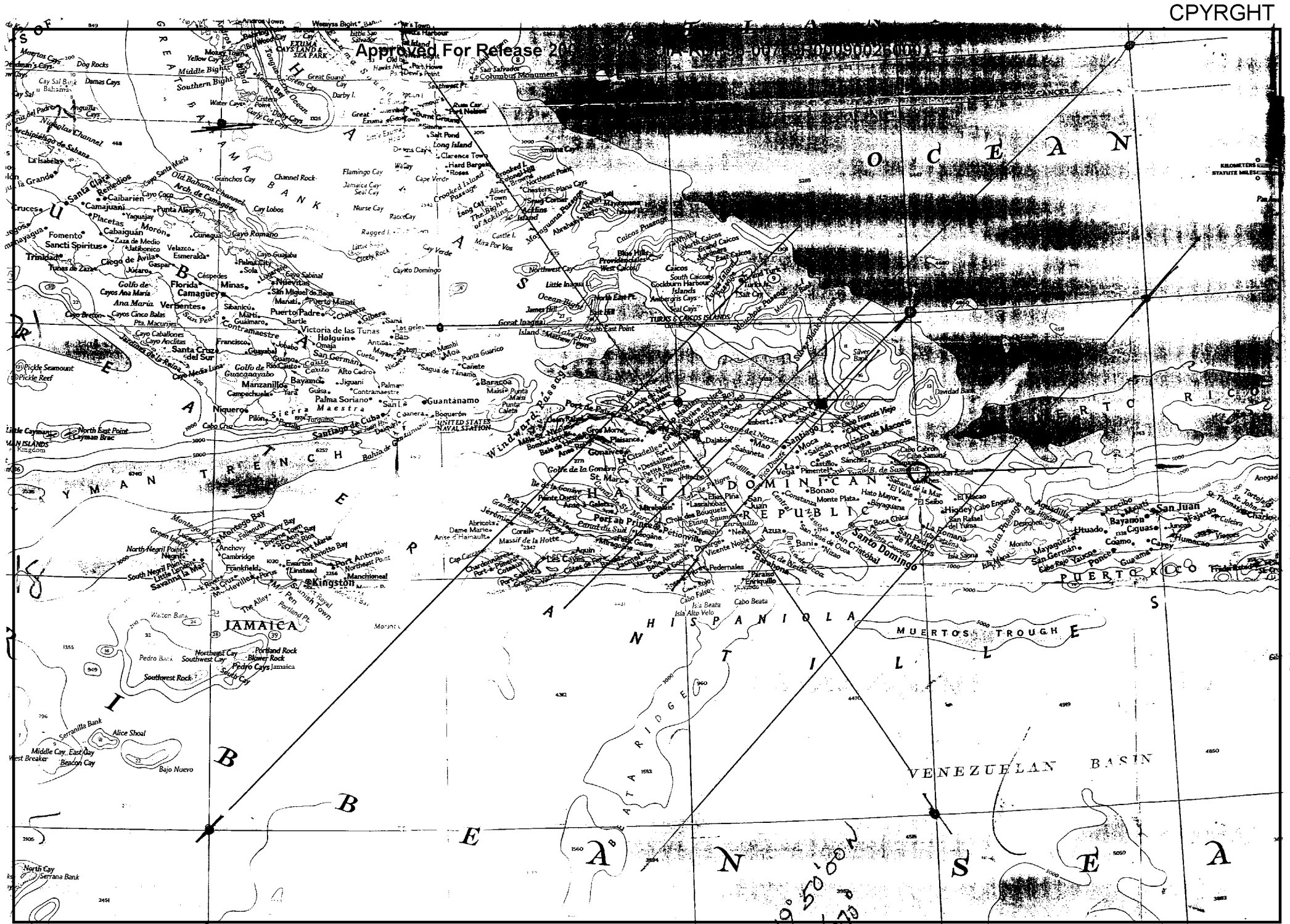
SUMMARY OF INFORMATION

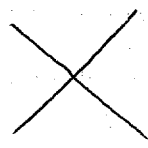
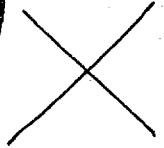




TOP of SUPER STRUCTURE(S) IF ANY
