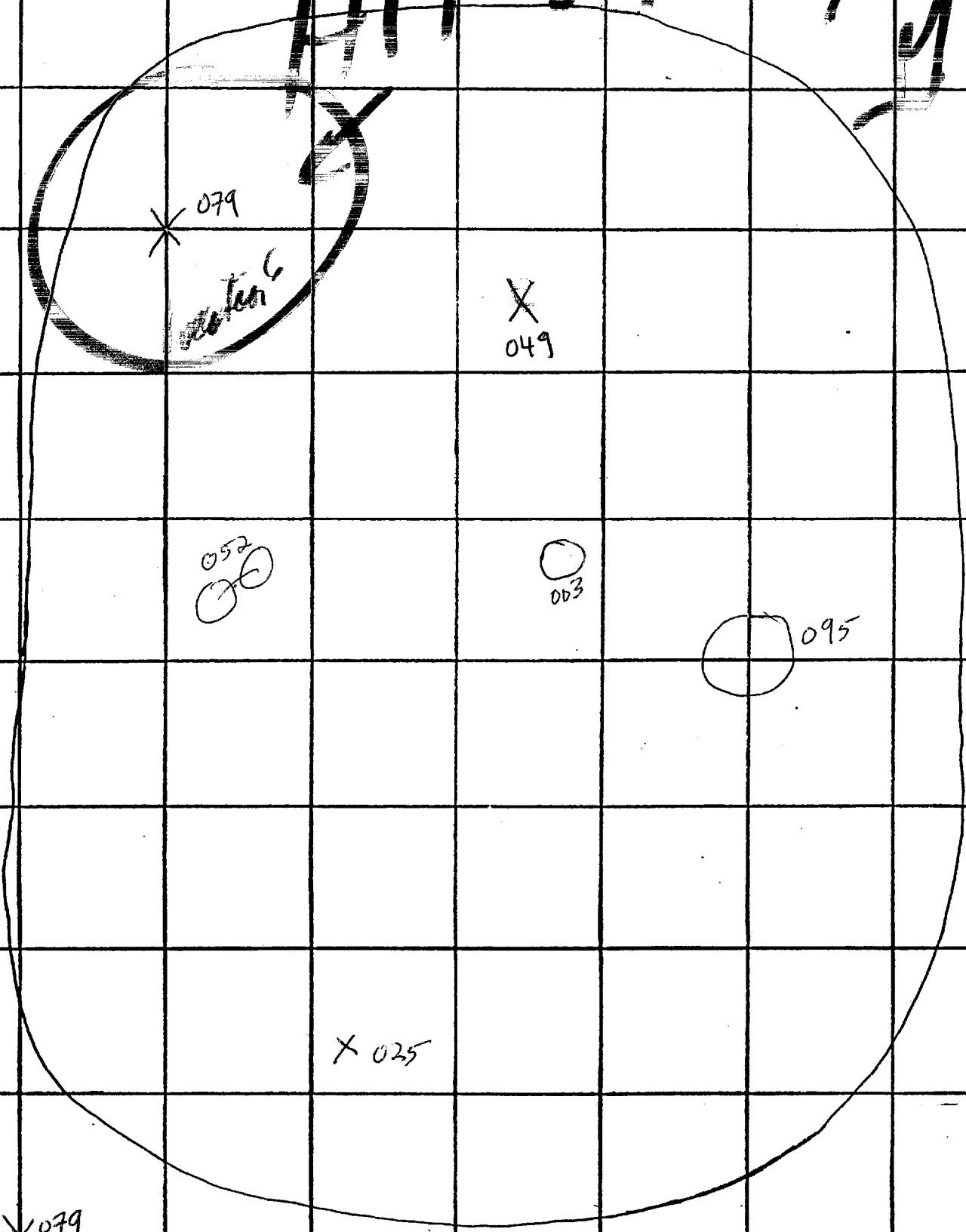

 - B. Describe salient, readily identifiable natural or manmade features that can help confirm the location for the contraband.

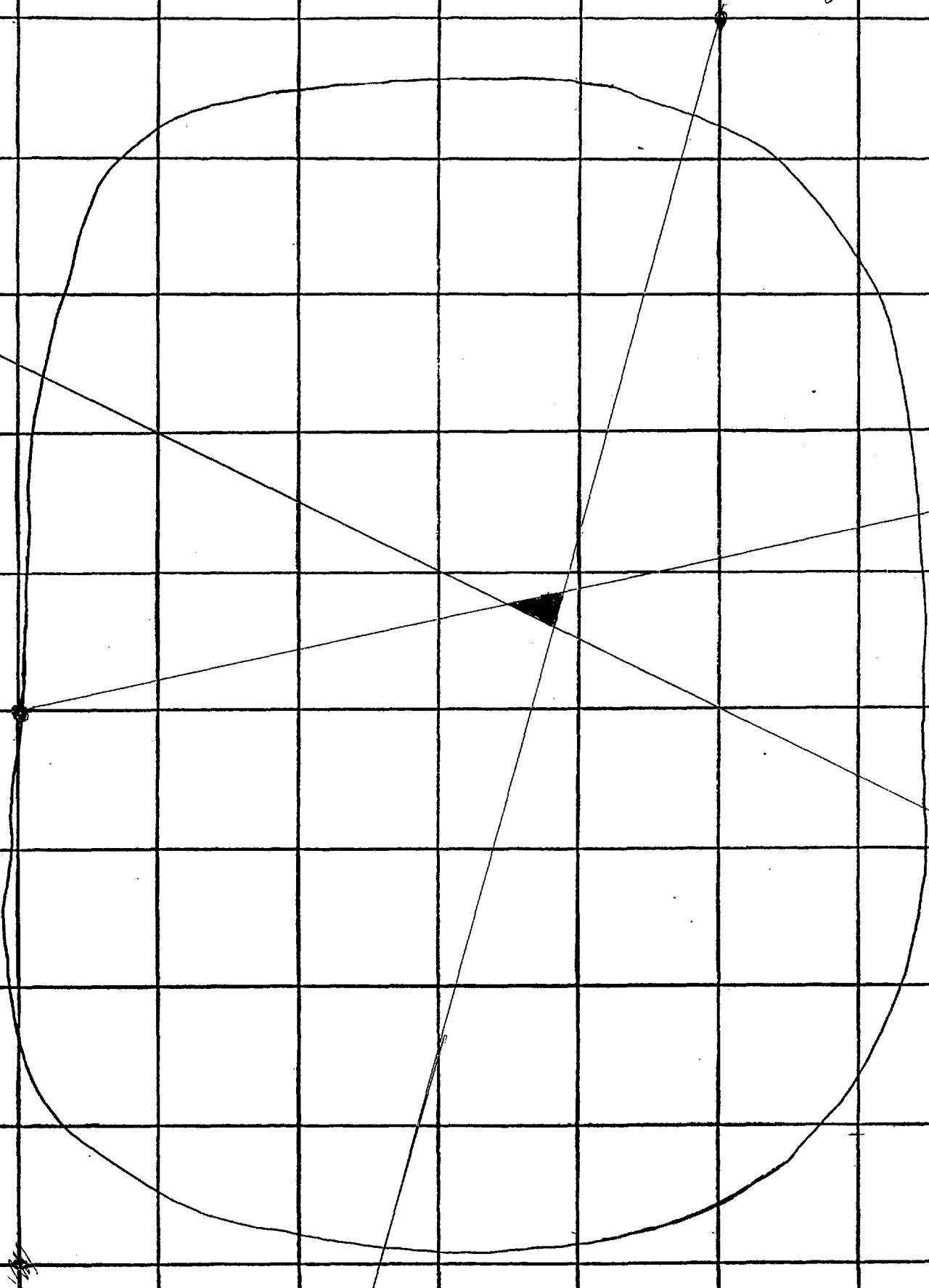
