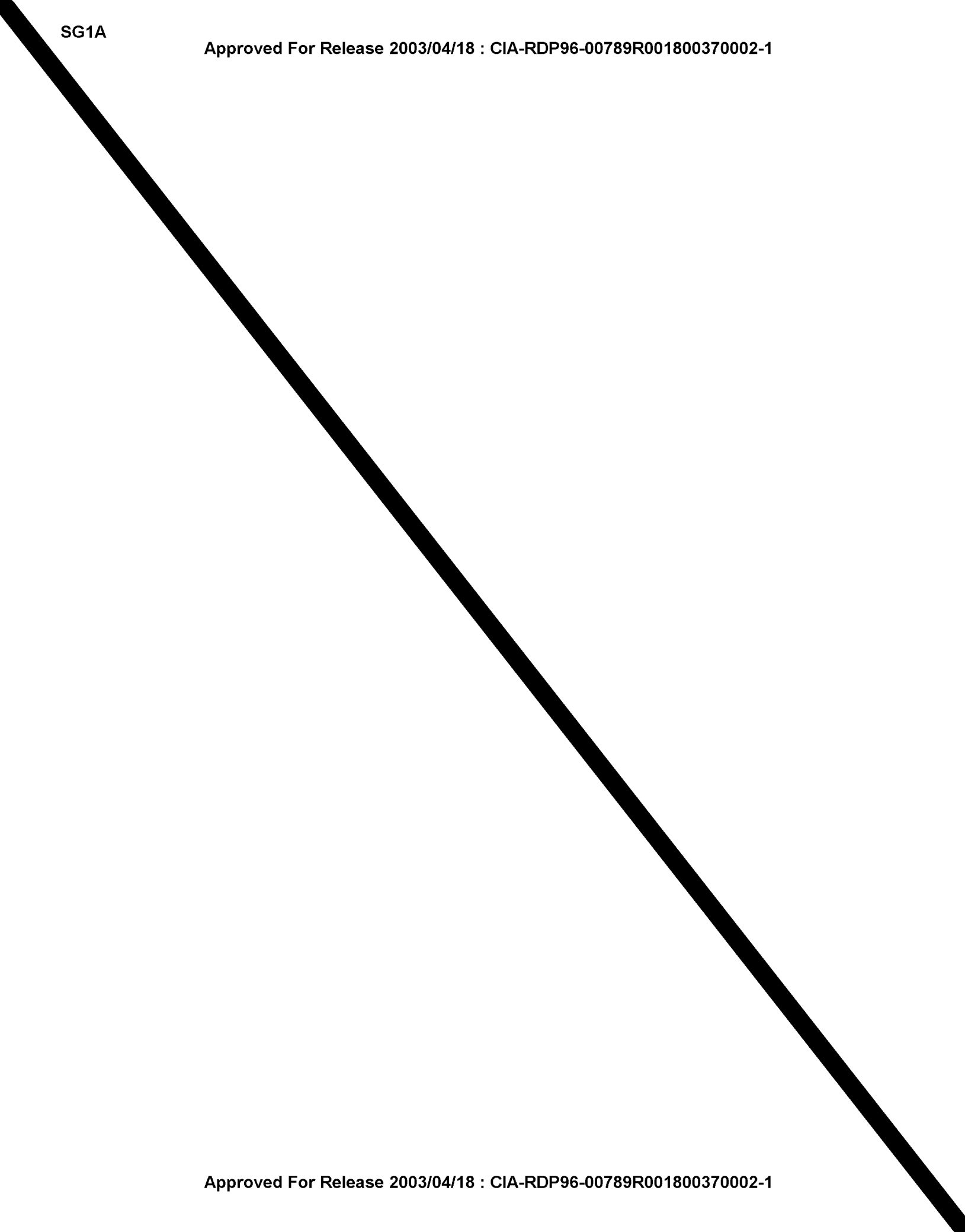

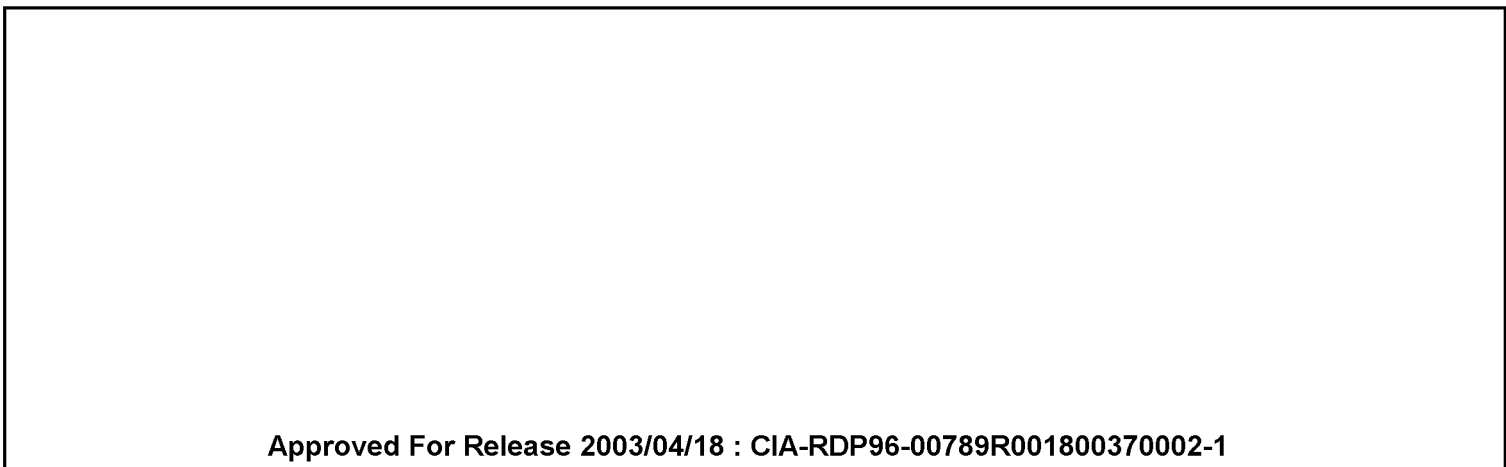

Ideogram detect mode functioned adequately, but decode of A and B was unsuccessful. Difficulty persisted on 21 Sep, but eventually was resolved. Session then proceeded very well, with viewer producing much accurate site- and mission-related data. Further post-session information/impressions received by viewer were even more accurate and relevant.

TO BEGIN WITH, WE HAVE A VERY COMPLEX, SOMEWHAT CONFUSING GESTALT. IT SEEMS TO CONSIST OF, AT LEAST, FOUR PARTS, ALL INTERCONNECTED SOMEHOW. THESE SEPARATE ELEMENTS ARE: (a) A LARGE, MAN-MADE STRUCTURE/OBJECT, (b) AN AIRY, CLOUD-LIKE PERCEPTION, (c) A SMALLER MAN-MADE STRUCTURE/OBJECT, AND (d) A PERCEPTION OF LIQUID/WATER, FLOWING LIKE A TIDE, OR RIVER.

THERE IS A PERSON ASSOCIATED WITH THIS TARGET. HE SEEMS TO BE ONBOARD A BOAT, OR SHIP. HE IS DRESSED IN BLUE JEANS, TENNIS SHOES, A RED AND WHITE STRIPED T-SHIRT, AND IS WEARING A BLUE JEAN JACKET. HE IS ABOUT AVERAGE HEIGHT, SLENDER BUILD, WITH BLACK HAIR AND LOOKS TO BE ABOUT IN HIS MID-TO-LATE 30s. THIS INDIVIDUAL HAS AN EVIL, RUTHLESS, CRIMINAL MIND. IDEAS OF ROBBERY, STEALING, EXTORTION, SMUGGLING AND VIOLENCE ARE VERY STRONG, (AOL/S - LIKE A PIRATE).

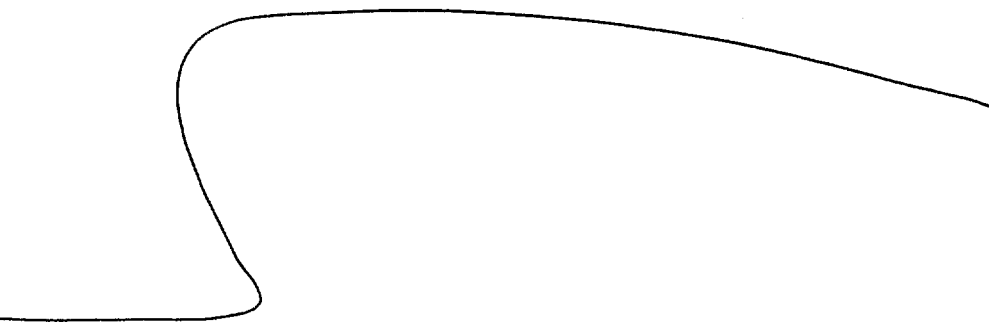

WATER IS WARM, CLEAR, SHALLOW

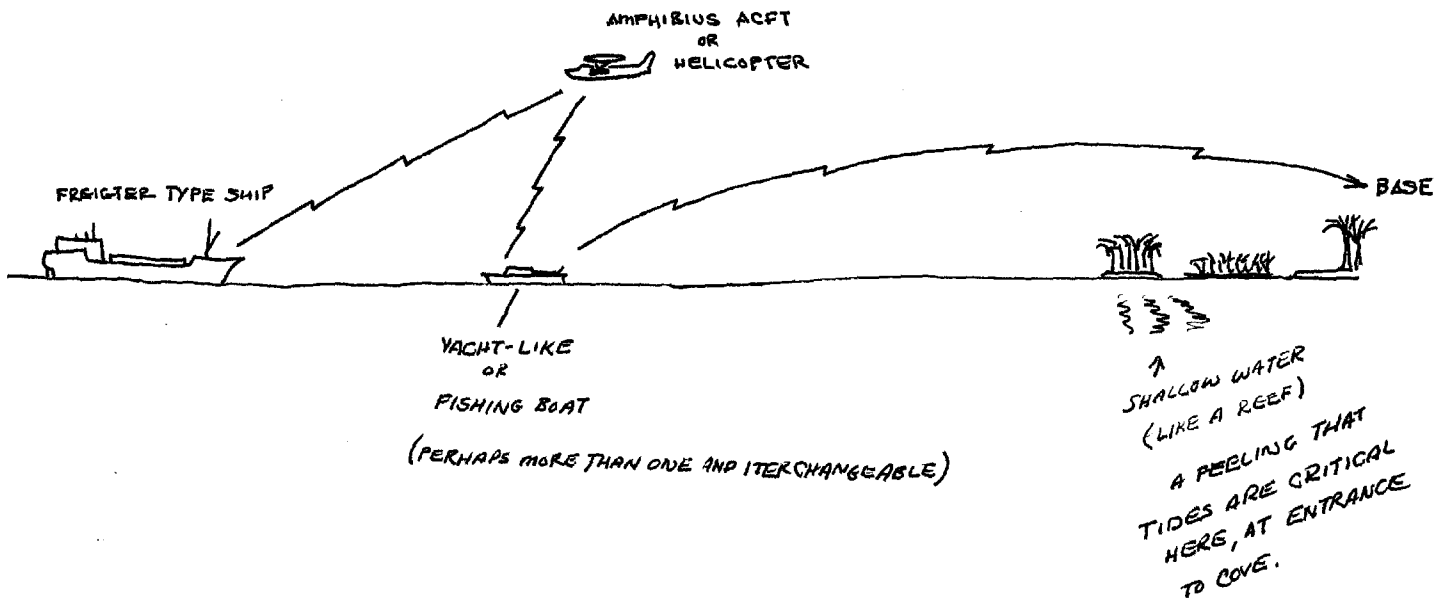
