1. (U) Personnel:

- PAG-TA continues to have three civilian vacancies (two long-standing and one resulting from retirement in June 93). Our authorized strength remains at 10 with seven assigned civilian personnel.
- No change in status on our submission for civilian hire to conduct foreign assessments.
