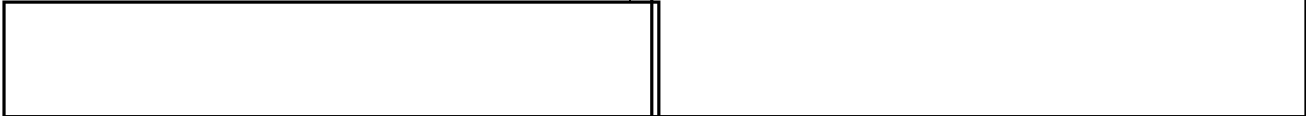

1. (S/NF/SK) MISSION: Determine why personality of interest was transferred/demoted; the nature of info to be provided the US; how this will benefit the US;

2. (S/NF/SK) VIEWER TASKING: Session 02 is considered an operational session. For this reason, Viewer 079 was front loaded with EEI reflected in Para 1, above. Data related to this personality was obtained during the course of a previous session conducted on 4 February 1988.

3. (S/NF/SK) COMMENTS: No physical inclemencies were noted. Attempts to obtain specific numbers and specific spellings of countries and people revealed that this can be done but with a great deal of effort. The presence of "repeated and varied" estimates indicates a deterioration in the accuracy of the data revealed; at that time, it would seem to behoove the interviewer to simplify the task, specifically, obtain an estimate rather than a number, a phonetic of a name rather than its literal spelling. Much remains to be learned from the WRV methodology. A narrative summary of the information is attached as Enclosure 1.

SUMMARY

1. (S/NF/SK) The Personality of Interest (POI) was politically demoted and transferred for his former ~~prestigious position~~ as a result of his ~~strong disagreement~~ with the "man-in-charge" (chief of state?) on an ~~issue of international concern~~ and significance. The POI was described as a "man of communist backing." The POI is a political survivor; his friends, and his military associates in particular, will not be affected or ~~demoted~~ as a result of the POI's ~~near demise~~. At this time, the POI is under a great deal of ~~stress~~ because of his ~~concerns~~ regarding his ~~political survival~~; his wife is also a matter of concern to him. The POI is a dark complected individual with dark black/brown hair and dark eyes. He is considered tall, dark and ~~successful~~ and charismatic almost at will. He (the POI) is less than six feet tall and his current ~~stressful situation~~ appears to be affecting him physically. The POI is a representative of either Oman or the United Arab Emirates; somehow the interests of these two countries are represented by the POI.

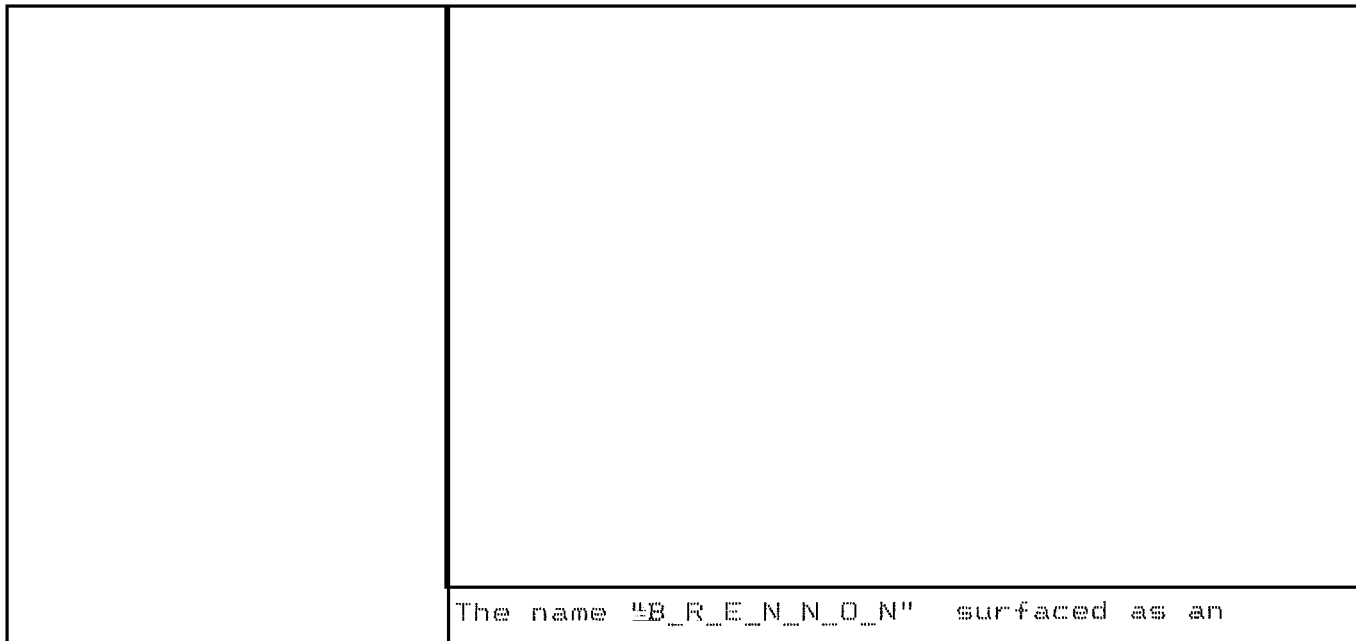
2. (S/NF/SK) The US will benefit from the receipt of ~~technical~~ information obtained from a "~~Foreign Material Center Study~~" related to a "missile - nuclear warfare center." The information will be provided on a "missile, nuclear warfare head" (that is ~~located~~ in a center (place of research)). The data will be used

The name "B_R_E_N_N_O_N" surfaced as an identifiable intermediary between the POI and the US. The connection is or will be made between the intermediary and the and the US. The intermediary is ~~withholding information~~ (from the US). There was additional confusion as to whether or not BRENNON was ~~employed/recruited~~ by a US intelligence agency or whether he (BRENNON) was also ~~reporting~~ the data to a third ~~country~~.

4. (S/NF/SK) COMMENTS: When the information becomes ambiguous as in the case of the exact numbers or whether BRENNON is employed by a US intelligence agency, or is in fact a double agent, then the information would seem to be unreliable. If considered germane to the issue at hand, then the point of interest should be the subject of another session. This data may already be known to the customer.
