- TASKING: Describe the location where LTC Higgins is being held, and any specifically identifiable structures nearby. Locate his position on a map.
- 3. (S-SS)SESSION CONDITIONS: FI: none AV: none.
- 4. (S-SS) RESULTS:
- LOCATION: Impressions of flat land with nearby water and distant mountains. A structure was located which gave the impression of being small and oddly shaped (see sketches, pages 9, 11, 12). There were repeated strong impressions of garish, ugly colors and an extreme amount of noisy commotion outside the structure. The outside surface of the structure seems to have the appearance of plaster which has been smeared on using hands rather than tools. inside of the structure appeared to be empty of furniture, It seemed somehow bi-level, since the floor seemed lower than the opening to the outside.
  - PEOPLE: There was a perception of only two people:
- A man in a white shirt and dark slacks sitting on the floor, against a wall. This man was upset, bored, and hungry. He was feeling very irritated at the harsh sounds which constantly came in from the outside.
- 2) Another man stood in the opening to the outside. He was perceived as wearing a white shirt and blue pants. He was leaning against the side of the opening, not facing the other man, but he would look around at the other man now and then.

- 3) There seemed to be no discussion or communication or contact going on between the two men.
- 4) There were no perceptions of anyone else being in the structure.
- 5) There were no perceptions of weapons or violence.
- c. OTHER: Stage 6 perceptions of present location and predicted location as of 26 FEB 88 were requested. See pages 16 and 18 for locations and lines of travel of connections between them. On these drawings:
- $\,$  1) "X" stands for the place where he was kidnapped.
- 2) "H" stands for his location at the time of the session.
- 3) "26th" stands for his predicted location on 26 FEB 88.

 4) It was not explained to me what "R" stands for,

d. A stage 7 perception was received in the form of a series of words (see page 13). They were "raising", "raisin", "reason", "rheon". This is taken to be the signal line expression of "Ras Ain", where he was abducted.
