SG1B [REDACTED] is a "little girl" abducted by a "southerner," a man described as tall and thin.

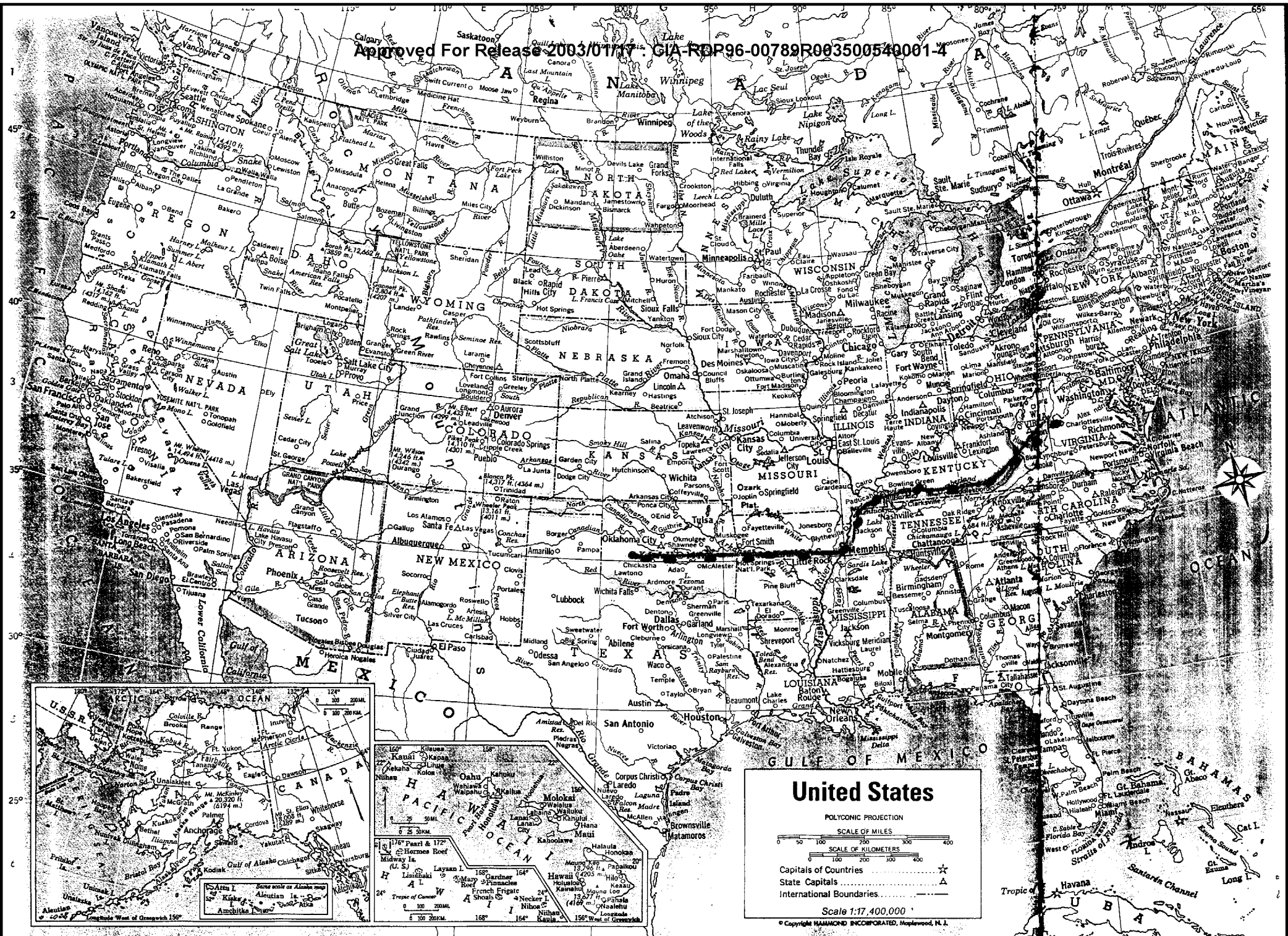

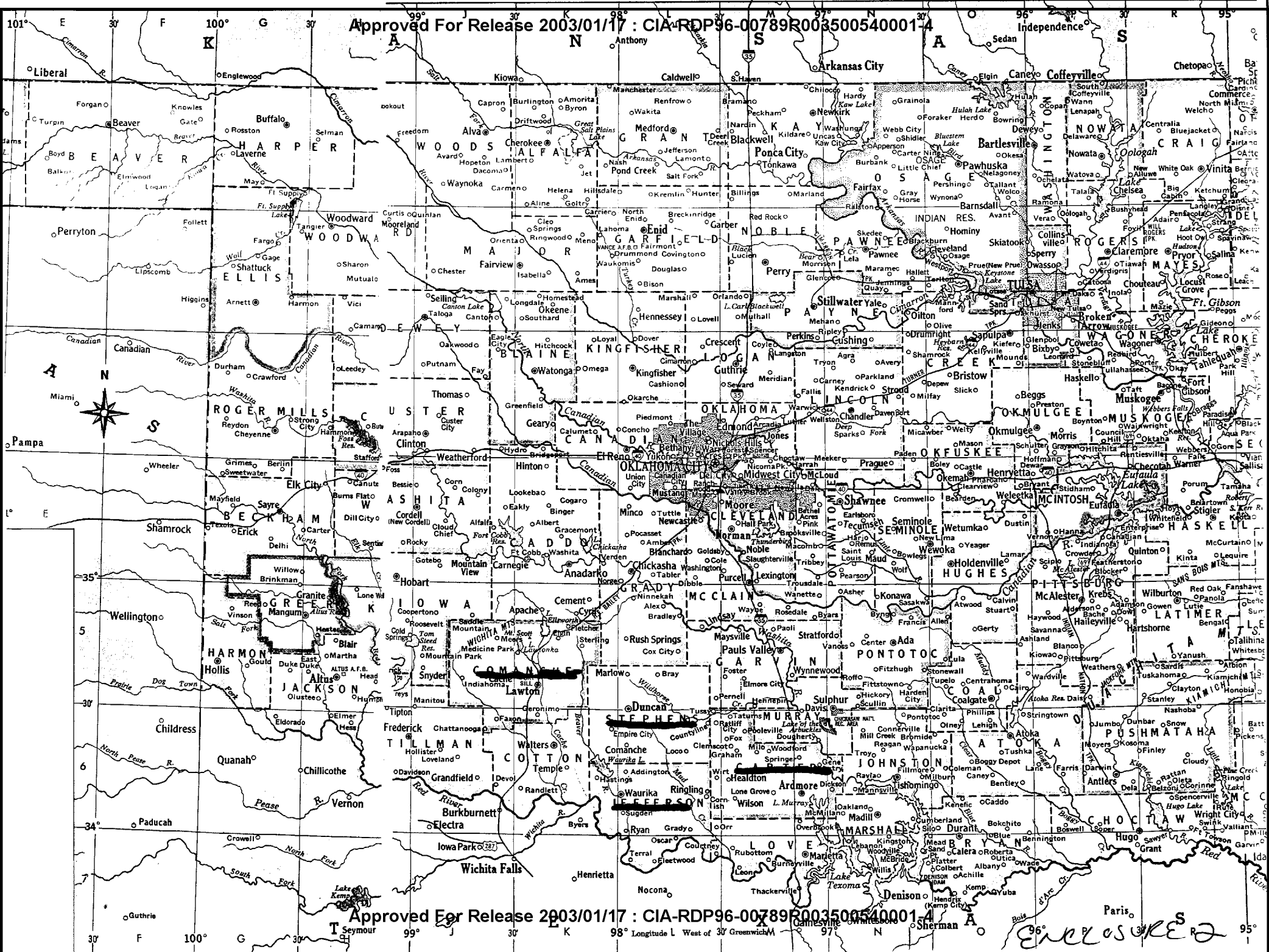
