1. (S/NF/SK) TASKING: The tasking provided to the Interviewer in the cited reference above was no changed. In this final session, Source was again only told that this was a continuance of the mission involving, "the odd shaped building" and that the specific areas of interest within that building would be designated during the actual session. In each session Source was always provided the same encrypted coordinates as per Extended Remote Viewing protocols. No other cuing or descriptive data pertaining to this target was provided to Source except that which is referenced above.

2. (S/NF/SK) In the final set of tasking provided to Source during this session, "LOCATION 11", She became very uneasy and unsure of Her answers and at times bordered on displaying symptoms of very real anxiety. In the post session interview She stopped writing Her post session summary and asked very seriously, "was I in a bathroom". This was a fascinating question since in fact, LOCATION 11 is a sports hall (gymnasium) with most assuredly, multiple sets of showers and toilet facilities. Source's anxiety then, could be explained by Her subconscious realization that She had "intruded" into a men's locker room. Other than this somewhat light hearted incident, there were no other reportable anomalies or incidents which occurred that may have influenced that data provided by Source in this report.

3. (S/NF/SK) SUMMARY:

a. (S/NF/SK) The following narrative, contained within quotation marks, is an abridged copy of Source's post-session written summary. This summary has been editorialized, (as indicated), by the undersigned for clarity, grammar and structure. The actual

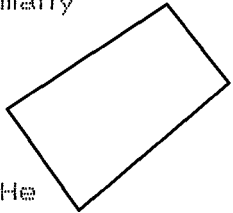

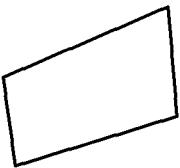

SG1A

"When I first came to the structure, I saw that it was full with many entrances and many windows. I felt that the men were building something new on to the structure. I felt that there was a large round, mirror placed on the ground facing the structure. Upon entering (the structure), I sensed a lot of people entering and exiting. It was a gliding motion. Moving fast. (At) FLOOR 6, LOCATION 4, I saw a man in charge sitting at an expensive desk. He was sitting in between two pieces of expensive furniture. I felt that many men reported to him. He was a decision maker. (He was) a tall thin man. I sensed a flag here (and) decorated hats and ribbons (military hat braid). The man here was high ranking. The people who reported to him were serious and conscientious. I sensed an object which was thin and (had) gold (colored) loops on it, lying flat (on the desk). The men who reported to him were the ones who went out and did the (work here). They had to analyze (as a function of their job) but when they reported back, the reports were straight-forward and only factual. There was a special job these men did. They were sent out to a hot grassy area to keep watch. This area consisted of structures which all looked alike but then, for some reason, the men ended up in a very expensive structure. These men did a (job which required watching). (At) FLOOR 7, LOCATION 4, I sensed another man. He was shorter and physically stronger. He was not as high ranking as the man I just described but he was very forceful. he sat behind a round desk. He was responsible for the movement of men. he needed to know and understand exact timing. He has to know the little things. There was a cabinet here. I sensed there were papers that were kept hidden or separate from the regular filing system. These special papers said something about turning an object almost upside down and thought it was due to something but was not. I also sensed this man held a small case in his hand and he opens it to lock it. (Monitor Note: The above cited areas are alleged to be components of [redacted] (At) LOCATION 11, I sensed men relaxing, taking a break, talking. A group of men sitting down. I felt I was watching a movie at one point. I kept sensing audiovisual or usual. Then I sensed a man half-dressed, drinking water. he had black hair. I sensed a cooling down. I sensed a light fan. At one point, I felt like I was in church. This location was "L"-shaped and I felt that this was in an older section of the structure. I sensed water. At one point, I felt That I was in a bathroom." b. (S/NF/SK) In addition to the data provided above, Source provided other information during the actual session which may impact on the final analysis. Key elements of that information is provided as follows:

1). (S/NF/SK) Within the office of the individual who sat at, "an expensive desk), cited above, Source also reported that, "meetings are held here, lectures, briefings. At times specialist are brought in...". The "gold, looped" object apparently was a desk ornament or other similar ornamental item which was, "lying flat, twisted, bent...symbolizing the history and past...".

2). (S/NF/SK) The functions of the people in this office included, "(placing) men in high places and they continue to move up while they watch...They don't miss anything. Look at all sides...". Within the actual work areas, the, "security is tight, tightly controlled...".

3). (S/NF/SK) In the associated offices where a "shorter, stronger" Source reported a "shorter, stronger" man in charge. This individual is further described as an someone who, "knows the little things in a plan. Takes time to the see the little things. What to do if something occur (goes wrong), contingencies...(he) disguises people, he hides people...controlling people...". One of the documents located in this individuals office was perceived by Source in stilted and erratic terminology as follows: "November 1978, .5 DMs - could have cancelled but did not - other occurrence did - alternate way via planned program placed object - find point "A". A second document, also perceived in an erratic and unclear manner, is quoted as follows: "Information placed in tabular sections were held up in accordance/because/in accordance with laws, pertaining to law. This resulted in a (non) concurrence for #4". The collective meaning of the documents as pertains to this office was perceived by Source as dealing with, "Watchful quietness. Subtle behavior, observing little things. Doing things that other people don't even notice. Tricksters. having implications of security. Wide views, changing, alternating, placement of people, studying, examining, under close watch...".

4). (S/NF/SK) At LOCATION 11, allegedly a sports hall or gymnasium complex, Source also reported the presence of, "balls...smashing down. I don't like it here...very physical here. Men resting, sitting on the floor, cooling down...a lot of energy here, putting out of a lot of energy...men laughing, enjoying...". Source may have also reported on the presence of a lockerroom when She reported, "when men leave this area (they) step out and close a section then lock it...they carry a box in (their) hands...compartments...this is (a) private (area)..."

4. (S/NF/SK) OPS FEEDBACK: The Source provided extremely relevant descriptors of both areas which, in the opinion of the Monitor, left very little doubt about the accuracy of Her reporting. Her ability to make the sudden shift from a rather sinister area,

[redacted] to something as light and non-threatening as the sports hall are indicators of this Source's excellent control over the Remote Viewing phenomena. Based on the presumed accuracy of the reports to date, it is recommended that this mission be terminated with no requirement to follow up with another "search" [redacted]
