SUMMARY OF INFORMATION:

SG1A 1. (S/STD) Is the callsign \_\_\_\_\_associated with a vessel or a land station?: A vessel.

2. (S/STD) If a vessel, give:

a. <u>Description</u>: Large. Sides are black from waterline up to a narrow cream-colored band at the top. The foredeck is also light or creamcolored, and is bowed upward (see sketch, Fig. 1). The back end of the ship is pronouncedly rounded (see sketch, Fig. 2). The superstructure is also light cream-colored.

b. Location: At time of search (1307 hrs, 11 APR 90), ship was located at approximately 20 deg. 40' N / 68 deg 15' W. and appeared to be heading in a northward direction (see map, Fig. 3).

c. <u>Carrying contraband</u>?: Impression was of contraband in the form of arms/weapons.

d. <u>If so, where is contraband on board?</u>: At time of search (1315 hrs, 11 APR 90), I detected what appeared to be a cache of weapons located on the right side of the ship, slightly forward, approximately level with the waterline (see diagrams, Figs 4 & 5).

e. Name of the vessel: Repeated attempts produced "Her...",

General area not further specified in this session. There was a strong impression that the weapons would be dropped underwater for divers to pick up later.
