### REMOTE VIEWING SESSION #901


1. (S/NOFORN) This report provides documentation of a remote viewing session conducted for training purposes only.

2. (S/NOFORN) The protocol used for this session is detailed in the document **G**RILL FLAME Protocol, AMSAA Applied Remote Viewing Protocol (S), undated.

3. (S/NOFORN) Post session analysis on target viewing indicates the viewer had a considerable amount of correlation. The viewer's attitude was positive.

4. (S/NOFORN) Following is a transcript of the viewer's impressions during the remote viewing session. At TAB A are drawings and narrative made by the viewer. At TAB B is target cuing information. Also included is available target data.

### TRANSCRIPT

### REMOTE VIEWING SESSION #901

#66: This will be a remote viewing session for 1400 hours 12 May 1982.

### PAUSE

#66: Focus now on,

37 degrees 04 minutes 00\_seconds North 109 degrees 23 minutes 10 seconds West

and describe the target to me.

- #25: Got lines, at right angles, inverted, upside V, lots of them.
- #66: Describe the terrain to me.
- #25: Continent...land, grained...mixture of trees, pine and another kind of tree.
- #66: Focus now on the target and from the oblique, describe the target to me.
- #25: Have a building shape, square, rectangled building, white roof, white color, situated, rests in a small valley, not really a valley, an impression.
- #66: Describe the activity at the target.

#25: See children, like a day school, an open door, a few cars, not very many, lines down the road country feeling, the second the away, not really isolated, but not near dense population.

- #66: Describe the principal characteristic terrain feature in the area.
- #25: Back appears a hill or a mountain, that has an impression of the instead of peak, no peak, around it, and then it gets lower on the side.

### PAUSE

#66: I have no further questions concerning the target, But I would like you now, to focus on the target and explore beyond the confines of my questions. Explore now and comment as you see fit.

#25:

- The building's really white, like all parts are white, like a nun's clothes might be, have a different functions, but it is all white, like the roof is white, the sides are white. I think I have an overlay, problem as a church. Going overhead, see a small town, looks like a small town, there's a small river. Reminds me of a town in Texas, that I've seen before. Terrain is hilly, I keep wanting to make the building a church. See construction vehicles, caterpillar, bulldozer, get a peaceful feeling, like there's never a, new house full of blossoms, pleasant, slow moving pace, agriculture, (mumble) like high, maybe overfay, but I was creating something on top of roof, like a spire or a chimmey...can't tell about location, get a town like Texas, and I think that's overlay. Get Australia.
- #66: Watch your analysis, just report your impressions.
- #25: I see a globe of the world or of my attention goes to Texas and it goes to Australia, back and forth.

### DRAWING NARRATIVE

### REMOTE VIEWING SESSION #901

- #25: Okay, the following is the description of the drawings.
- #25: Drawing #1 is the impression, the first impression that I got of a bunch of lines, going like upside down Vs, like that. And that 's all it was, very simple drawing, image, black and white type image.
- #25: Drawing #2 is the building that I described, white building that was set on a hill type thing and I tried to draw like a hill, with a circle around it. That would indicate that that's the highest around in the building.
- #66: Did you say large hill or a small hill?
- #25: Oh, I couldn't tell.
- #66: Is it a mountain?
- #25: I couldn't tell if it was a mountain or a hill. It felt more like the hill, like it might be like a little area in between a couple hills or something like that. But it was, I don't know, I can't tell now whether it was large or small, I have too much problem with that.
- #66: Olay.
- #25**:** 
  - 5: Anyway, there was a road coming up to it, and it was made out of limestone rock type gravel and there was a building in there that was white and long, It had a white roof and white sides. It had something on the top and I've drawn here, to look like a spire. That might be an overlay thing, because it looked like it might be a church and I think that's overlay, because the first thing that I saw were these V shapes that go upside down and I associated that with the things that I heard before about how in remote viewing that when you see an inverted V, that means a church.
- #66: So you spent time in your head analyging, as opposed to looking at the target?
- #25: Well, I don 't know if it was that much time spent. I tried to put that away and say well, you know that's analysis, so I won't pay attention to it. But, I got a feeling aobut the building, that it might be like a school too, for small children. I saw some very small children, like a preschool or a nursery or something like that, where kids come for the day time, the day school.

- #66: Okay.
- #25: Drawing #3 is just simply a bigger representation of that building in drawing #2, without the hill top and closeup image of it. The door, I felt like it was open and there was some cars, maybe two to three cars at the most.
- #66: Okay, the thing on the roof now looks like it maybe it could be a chimmey.
- #25: Could be. I got two images there, one was bricks, the other was wood.
- #66: Okay.
- #25: So, it could be a chimmey instead of a spire, that which would make it look like a church or a small school, like a country school or something.
- #25: Drawing #4 is an overhead, higher elevation picture of the thing, in association with a road, a river and a town. And a small road going up to the thing and I realize now that road doesn't go that way. And it does come something like that and make a lot smaller road, a small gravel road.
- #66: All right. Now looking at the last drawing that you've done here, kind of review for me in general terms, the elements of the target.
- #25: Okay. In this drawing?
- #66: Yes.
- #25: Okay. It was ---
- #66: Using that drawing, review the entire target.
- #25: ---It was a man made structure on a continent. It, ah, I'm looking, give me cues as to what I'm supposed to say about the ----
- #66: Well, what does it, were there many, many man made structures around?
- #25: In the distance, small distance away, probably two to three miles, maybe as many as five miles, there was a small town.
- #66: Okay.
- #25: Residential: It felt like they were, it was agriculturally




- #25: ---environment. Yes.
