SUMMARY OF INFORMATION:

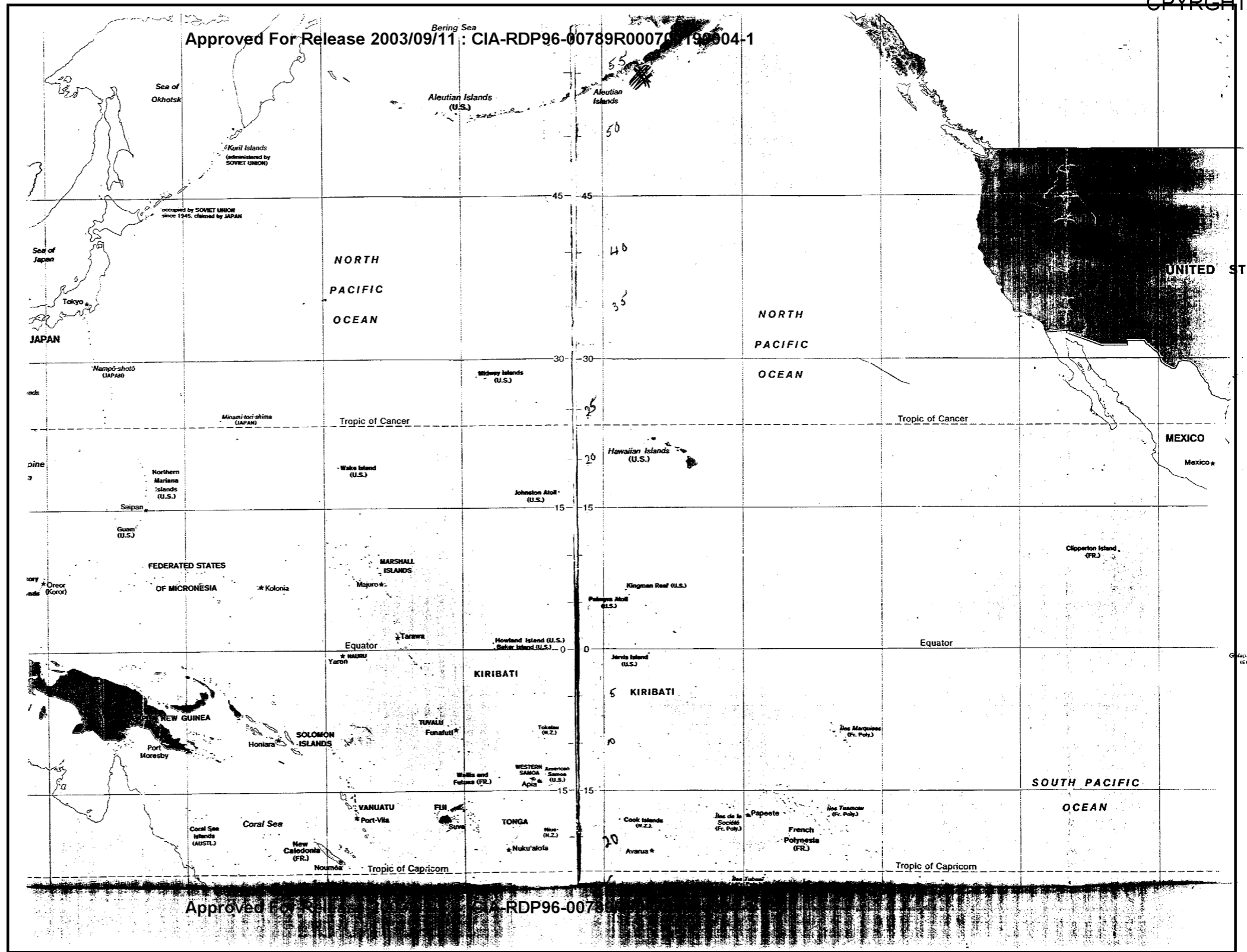
1. (S/STD) Physically describe the contraband: The contraband is a resin-like, brownish powder.
2. (S/STD) Describe how the drugs are packaged: It is in small packets taped w/ wide tape. It is concealed in some kind of tubes (NFI) which may be folded on the ends, but are stacked in a large bundle and covered with plastic.
3. (S/STD) Describe the current location and surrounding of the drugs:  
The large bundle of tubes or pipes is located on a dock in a port town (impression of smaller than a city) which is surrounded by near, rather high and fairly rugged hills. The language spoken here sounds like it is English. There is a "northwest" feel about the place.
4. (S/STD) Determine the location in terms of geographical coordinates:  
Vague impressions only around general area of 55 deg N / 60 deg W.
5. (S/STD) Identify and describe the ultimate destination of the drugs:  
Meaningless question. No answer obtained.
6. (S/STD) Is the  involved in the transportation of drugs?: Not this particular shipment of drugs at this time.
7. (S/STD) Is the  involved?: Not w/this shipment, now.
