WRAPPED in small, fist-sized clear plastic bags which are then wrapped in
RESPONSE: insulating materials. These are then stuffed in small, virtually
inaccessible nooks + crannies around machinery / engine across the stern (mainly starboard + center)
below the waterline D-F 10 on national grid.

4. If not, will it on-load illegal drugs? Where?

5. Where and when will the target vessel transfer/off-load the illegal drugs?

SUMMARY OF INFORMATION

The vessel is currently (27 1250L APR 90) at 15 N 74 30' W (south of Haiti) heading ENE. The vessel is carrying cocaine which is wrapped in small, clear, fist-sized, plastic bags which are then wrapped in insulating materials. These packages have been stuffed into small, virtually inaccessible nooks and crannies under and around engine(s)/pipes/machinery in the far stern of the ship (from starboard past the centerline), well-below the waterline (D-F 10 on notional ship grid).

The contraband will be transferred to a similarly sized vessel on 30 APR 90, under the cover of darkness (after 2200 hours) at a location east of the Turks and Caicos Islands (22 12'N 69 12' W). The second vessel will continue toward the US.

One of the call signs associated with the ship sounds like "MACHEEKA/MICHEEKA/CHEECA/CHICO."

There is the strong impression that at some point a helicopter will be involved in this operation.

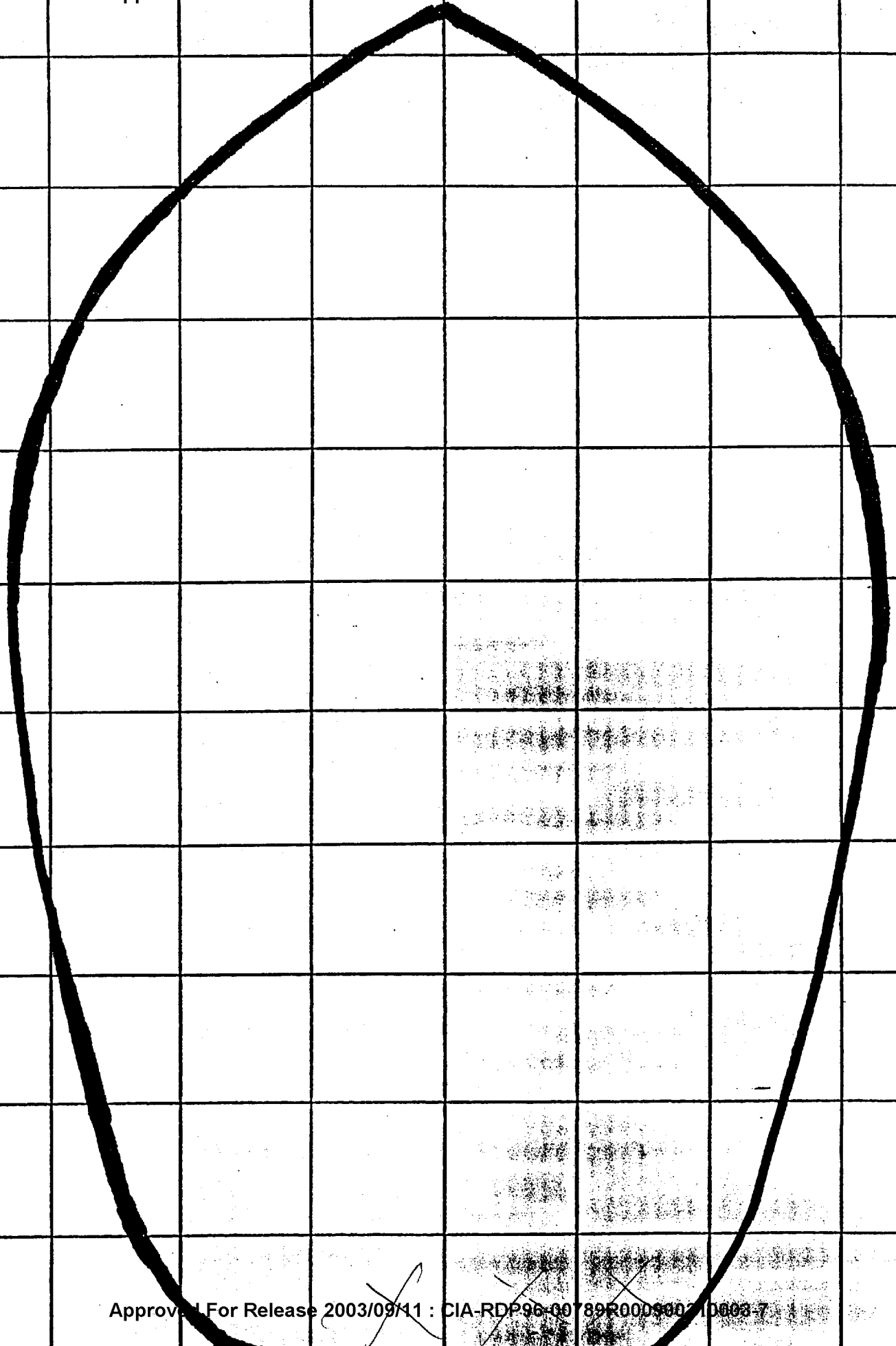
