SUMMARY OF INFORMATION

The target vessel is carrying contraband. The contraband is well hidden inside what I think is the hull, somewhere amid-ships. It was welded into place and will have to be cut open for extraction.

The current location of the vessel is ~~21~~^N 21, 12 min., ~~55~~^W 55, 40 min. ~~(Grand Bank, Newfoundland)~~. (about 800 miles ^N west of the ~~W~~ ^W ~~islands~~). The vessel has two routes to its destination where it will off load the contraband to ground transportation -- follow on transportation will be accomplished using smaller craft and multiple routes into the U.S., (these routes are indicated on the map attached).

The destination of the contraband for off-loading is * ~~45~~^{48° N} 45, 30 min and ~~55~~^{61° W} 55, 10 min. In the vicinity of ~~Point~~ ~~Placer and Miramichi~~ Grand Bank, Newfoundland.

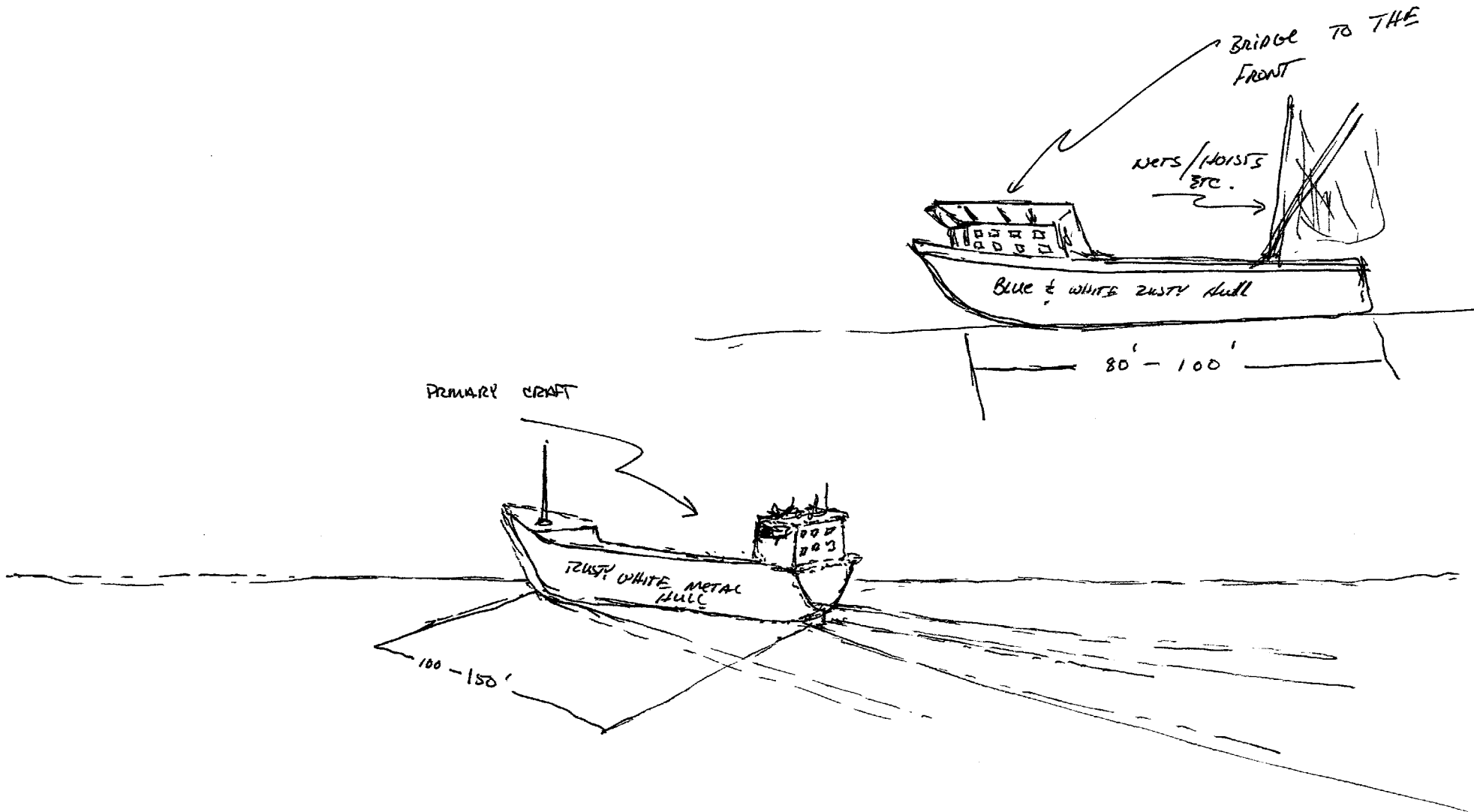

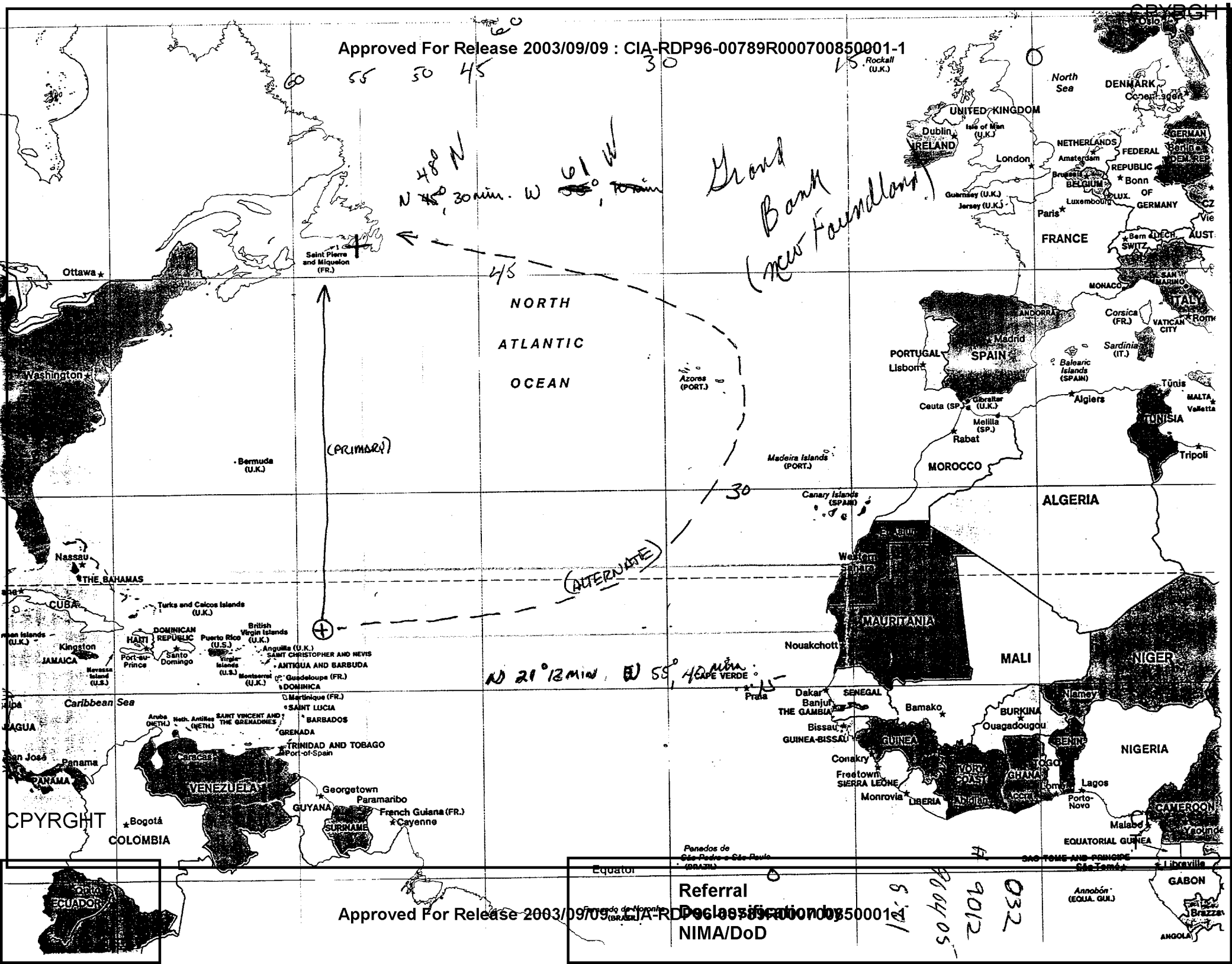
