TELEVISION INTERVIEWS WHICH WERE GIVEN IN SEPTEMBER OF LAST YEAR BY KASHPIROVSKIY; V. MEDVEDEV, CORRESPONDING MEMBER AND DEPUTY CHIEF SECRETARY  $\mathsf{OF}$ THE USSR ACADEMY OF SCIENCES; SCIENTIFIC V. KAZNACHEYEV, DIRECTOR OF THE INSTITUTE OF CLINICAL AND EXPERIMENTAL MEDICINE OF AMN SSSR'S SIBERIAN BRANCH. THE DECISION TO PERMIT BROADCASTING OF INTERVIEWEES ATTACKED KASHPIROVSKIY'S HYPNOTHERAPY SESSIONS OVER NATIONWIDE TELEVISION PRELIMINARY EXPERT EVALUATION OF CONDITIONS IN WHICH SUCH THERAPY IS ADVISABLE. CELLS. MENTIONED THAT JOINT WORK IN THIS PRODUCE ON LIVING HEDONE WITH AMERICAN SCIENTISTS OF A RESEARCH DIRECTION IS BEING MICHIGAN. ON THE BASIS OF THESE STUDIES, KAZNACHEYEV \_IN THAT KASHPIROVSKIY'S PROCEDURES ARE NEITHER PSYCHOTHERAPY CONTENDED HYPNOSIS BUT INVOLVE A DIFFERENT PHENOMENON AN INFORMATION AND WHICH IS TRANSMITTED FROM ONE PERSON TO ANOTHER EITHER FLOW DIRECTLY OR VIA TELEVISION. IT HAS BEEN DETERMINED THAT SUCH A FLOW CAN PRODUCE HARMFUL EFFECTS ON CELLS, REGARDLESS OF THE OPERATOR'S INTENTIONS. UNCONTROLLED USE OF THIS PHENOMENON DANGEROUS, IN KAZNACHEVEV'S OPINION.

KAZNACHEYEV THOUGHT THATTHIS PROBLEM COULD BE SOLVED ONLY BY COMPREHENSIVE STUDY OF THE ESSENCE OF LIVING MATTER, WITH THE PARTICIPATION OF SPECIALISTS IN AREAS OTHER THAN MEDICINE. HOWEVER. NO WORK IN THE FIELD OF BIOPHYSICS (AS DISTINGUISHED FROM PHYSICS OF LIVING MATTER) IS BEING DONE IN THE ACADEMY OF SCIENCES AT PRESENT. KAZNACHEYEV THEREFORE SUGGESTED THAT THE USSR UNION OF SCIENTIFIC AND ENGINEERING SOCIETIES' ALL UNION COMMITTEE ON INTERCHANGE OF ENERGY AND INFORMATION IN NATURE BE ENLISTED IN RESEARCH OF THIS PROBLEM, AND THAT SPECIALISTS OF AMERICA, JAPAN AND OTHER EUROPEAN COUNTRIES HE BELIEVED THAT SUCH POOLING OF TAKE PART IN IT. RESOURCES WOULD MAKE IT POSSIBLE TO OBTAIN RESULTS IN ABOUT A YEAR AND A HALF.
