SUBJ: EXECUTE ORDER (U)

EZ05:

1. (U) THIS IS AN EXECUTE ORDER BY AUTHORITY AND DIRECTION OF THE SECRETARY OF DEFENSE.

2. (C) SITUATION. THE DEPARTMENT OF STATE HAS URGENTLY REQUESTED THE DEPARTMENT OF DEFENSE PROVIDE TWO UH-1H HELICOPTERS TO SUPPORT THE ATTACHE OBSERVER COMMISSION IN ECUADOR AND PERU. THE FOUR POWER REPRESENTATIVES (ARGENTINA, CHILE, BRAZIL AND US) HAVE REQUESTED THAT THE ATTACHE OBSERVER COMMISSION VERIFY THE IMPLEMENTATION OF THE CEASE FIRE AND TO EXAMINE "IN LOCO" THE BEST WAY TO CREATE CONDITIONS FAVORABLE TO PEACE AND FRIENDSHIP BETWEEN THE TWO COUNTRIES. THE ATTACHE OBSERVER COMMISSION IS TO AVOID ANY REFERENCE TO BORDER QUESTIONS BETWEEN PERU AND ECUADOR. PERU AND ECUADOR HAVE SIGNED LETTERS OF OFFER AND ACCEPTANCE (LOA'S) FOR THE REQUIRED HELICOPTER SUPPORT.

3. (C) MISSION. CONDUCT OPERATIONS TO SUPPORT THE ATTACHE OBSERVER COMMISSION IN ECUADOR AND PERU.

4. (U) EXECUTION.

A. (C) REQUEST THAT USCINCSO DEPLOY TWO UH-1H HELICOPTERS AND AIRCREWS TO GUAYAQUIL INTERNATIONAL AIRPORT, ECUADOR. GUAYAQUIL INTERNATIONAL AIRPORT WILL BE THE MAIN OPERATING LOCATION FOR US OPERATIONS IN ECUADOR AND PERU. FORWARD OPERATING LOCATIONS WILL BE DEVELOPED THROUGH EFFORTS OF THE FOUR POWER REPRESENTATIVES AND THE ATTACHE OBSERVER COMMISSION IN COORDINATION WITH USSOUTHCOM.

B. (U) REQUEST THAT CSA PROVIDE MAINTENANCE PERSONNEL TO SUPPORT THESE OPERATIONS. INITIALLY, USCINCSO WILL PROVIDE MAINTENANCE SUPPORT UNTIL RELIEVED BY MAINTENANCE PERSONNEL PROVIDED BY CSA.

5. (U) COORDINATING INSTRUCTIONS.

A. (C) REQUEST DEPLOYMENT BE COMPLETED ON 6 FEBRUARY 1981. DUE TO THE NATURE OF THE OPERATIONS, A PROMPT RESPONSE IS REQUIRED TO ACHIEVE AN IN-THEATER OPERATIONAL CAPABILITY AT THE EARLIEST TIME.
