1. (FOLO) KIDNAPPING OF BG JAMES DOZIER, AS REPORTED BY GERALDINE WILSON, ANDRY TARASEWICH, AND BARBARA KUBIK PATTEN, KENT, WASHINGTON, PHUNE (206) 631-6806 (OFFICE), 631-8918 (HOME), PARAPSYCHOLOGIST, REFERENCE INITIAL SPOT REPORT, SAB, 2024COZ JAN 82.

3. (A) (FOUO) CN 21 JAN 82, FLMID WAS RE-CENTACTED BY WILSON, WHO HAD FURTHER VISIONS CONCERNING "THE PLACE OF THE SHEPHERDS" THAT SHE DESCRIBED IN THE INITIAL REPORT. IN HER PSYCHIC TRANCE, WILSON LOCKED INTO ONE OF THE SHACKS. THERE WAS A BEAUTIFUL GIRL SINGING TO A SMALL BABY. SHE PLACED THE BABY IN A CRIB AND WENT UP THREE STEPS INTO ANOTHER ROOM. IN THE ROOM THERE WAS AN OLD MAN—NOT BG DGZIER—LYING IN A BED. THE GIRL AND THE CLD MAN ARGUED IN ITALIAN; WILSON

FELT HE WAS THE GIRL'S GRANDFATHER. HE KEPT SHAKING HIS HEAD, "NO." AHE KEPT SAYING, "YES." IN THE MIDST OF THEIR ARGUMENT, A ROUGH LOCKING YOUNG MAN WITH DARK HAIR WALKED IN. HE WAS DRESSED IN RAGS AND TATTERED CLOTHING. THE GIRL AND THE OLD MAN STOPPED TALKING, AND WILSON FELT THAT THEY WERE AFRAID OF THE YOUNG MAN. SHE ALSO FELT STRONGLY THAT THE YOUNG MAN HAD SOMETHING TO DO WITH BG DOZIER. AND THAT THE GENERAL WAS SOMEWHERE CLOSE. WILSON SAW THE SHEPHERDS CO-OPERATING WITH THE CAPTORS, AND FELT THAT THE RED BRIGADE HAD HIDDEN WITH THE SHEPHERDS BEFORE. SHE FELT STRENGLY THAT THE SHEPHERDS HAD HIDDEN GROUPS FROM THE LAW, AND SHE WAS CERTAIN THAT THIS TIME THEY ARE HIDING BG DOZIER'S CAPTORS. THE SHEPHEROS TRUST NO ONE; THEY FOLLOW ONLY THEIR OWN LAWS. THEYARE ALSO FEARFUL OF THE KIDNAPPERS. SHE FELT THAT THERE WAS A CASTE SYSTEM WITHIN ITALY, AND THAT THESE SHEPHERDS WERE ALMOST AN ALIEN NATION. ABOUT THE "PLACE OF THE SHEPHERUS," WILSON TRIED TO LOOK AT THE MAN ON THE MOUNTAIN DURING A PSYCHIC TRANCE. HE WAS DRESSED AS A SHEPHERD, BUT ON THE MOUNTAIN HE COULD NOT BE TENDING HIS SHEEP, SO SHE FELT STRONGLY THAT HE WAS A LOCKOUT FOR THE CAPTORS. WILSON FELT THAT THE "PLACE OF THE SHEP-HERDS." AND BG DCZIER WERE DEFINITELY CONNECTED. B. (FOUO) ON 21 JAN 1982, BARBARA KUBIK PATTEN TELEPHONED THE FLMID AND STATED THAT SHE WISHED TO ASSIST FLMID AND ANY OTHER GOVERNMENT AGENCY IN LOCATING BG DOZIER. SHE ENUMERATED OTHER LAW ENFORCEMENT AGENCIES THAT SHE HAD WORKED WITH; HER CONNECTION WITH OTHER AGENCIES HAS NOT YET BEEN VERIFIED. PATTEN STATED THAT ON SIX OCCASIONS SHE HAD BEEN ABLE TO SUCCESSFULLY LOCATE MISSING PEOPLE. WHEN SHE PASSES HER FINGERTIPS OVER A MAP, IT FEELS LIKE THERE IS AN ELECTRIC CURRENT WHEN SHE GETS TO A POINT WHERE THE MISSING PERSON IS, THE CURRENT INCREASES DRAMATICALLY. PATTENT WENT TO THE CITY LIBRARY. KENT, AND WENT OVER NUMEROUS MAPS OF ITALY, INCLUDING THE ONE PROVID-ED BY TARASEWICH. PATTEN FELT NO PARTICULARLY STRONG VIBRATIONS FROM THAT MAP. PATTEN STATED THAT SHE HAD NO FIRST HAND KNOWLEDGE OF THE DIZIER KIDNAPPING UNTIL SHE DISCUSSED IT WITH WILSON AND TARASEWICH ON 10 JAN 82. AT THAT TIME SHE HAD BEEN HAVING VISIONS OF A STEAMER TRUNK AND A SMALL BLUE CAR. CN 21 JAN 82, WHILE READING A COPY OF A NEWSMAGAZINE, SHETREALIZED THAT IT WAS OBSCLETE INFORMATION. AT THE TIME, SHE DID NOT KNOW THE SIGNIFICANCE OF THOSE VISIONS. PATTEN'S FURTHER VISIONS SINCE 10 JAN 82, CONCERNING BG DGZIER, HAVE BEEN OF CLANGING METAL, POSSIBLY AS IT RELATES TO A METAL FACTORY OR FOUNDRY. IN HER VISIONS SHE SAW A HALLWAY WITH LOTS OF CEMENT BEHIND METAL SHE CONTINUED TO HEAR CLANGING METAL. SHE FEELS STRONGLY THAT

THE HALLWAY SHE SEES IS LOCATED IN AN UNUSED SECTION OF A FOUNDRY, A MILITARY BASE, OR ANOTHER PLACE WHERE METAL IS WORKED ON.

C. (FOUO) ON 22 JAN 82, WILSON TELEPHONED FLMID TO RECOUNT HER LATEST VISION CONCERNING BG COZIER. WHILE IN A PSYCHIC TRANCE, SHE SAW THE SHEPHERDS AGAIN. SHE FELT THAT SINCE THEY PARTICIPATED IN A COMMUNAL WAY OF LIVING, THEY WERE IN EMPATHY WITH THE COMMUNISTS (WHICH WILSON CONSTRUES AS THE RED BRIGADE). THE SHEPHERDS THINK THAT THE COMMUNISTS WILL CHANGE THEIR STATION IN LIFE. WILSON FURTHER THINKS THAT THE ITALIAN POLICE ARE AFRAID OF THE HERDSMEN. SHE FEELS VERY STRONGLY THAT THE POLICE DO NOT WANT TO GO INTO THE SHEPHERDS! AREA, WHICH WILSON BELIEVES IS UNDER RED BRIGADE CONTROL. SHE STILL SEES THE KIDNAPPERS MIXED AMONG THE SIMPLE SHEPHERD PEOPLE. WILSON SEES BG DOZIER AS A VERY STUBBORN MAN THAT WILL NOT BREAK UNDER PRESSURE. WILSON SEES A LOT OF BLOOD-SHED, AND FEELS THAT THE FAMILIES OF US SERVICE—MEMBERS IN ITALY SHOULD RETURN TO THE US. STATED THAT SHE HAS ONLY BEEN ACQUAINTED WITH WILSON AND TARASEWICH FOR THREE MONTHS. ALL SHE KNOWS IS THAT THEY APPEAR TO BE COMPETENT AT PSYCHIC PHENGMENON, AND THAT THEY ARE IN FINANCIAL DIFFICULTY. WILSON AND TARASEWICH EXPRESSED TO PATTEN THEIR INTEREST IN THE \$2 MILLION (\$1.8 MILLION) REWARD BEING OFFERED FOR INFORMATION LEADING TO THE SAFE RELEASE OF BG DOZIER. PATTEN STATED THAT SHE WAS NOT INTERESTED IN THE REWARD. IT IS HIGHLY LIKELY THAT WILSON AND PATTEN WILL CONTINUE TO CONTACT FLMID ON A REGULAR BASIS TO PROVIDE INFORMATION ABOUT THIS MATTER, AND ANY OTHER MATTER THAT THEY PERCEIVE IS TOF INTEREST TO MILITARY INTELLIGENCE.
