#### SUMMARY ANALYSIS



#### REMOTE VIEWING (RV) SESSION CC35

- 1. (S) This report documents a Remote Viewing (RV) session conducted in compliance with a request from SOD, J3, OJCS, Pentagon, Washington, D.C. The purpose of the session was to provide information relevant to the hostage situation in the U.S. Embassy compound in Teheran, Iran.
- 2. (S) The remote viewer's impressions of the target are provided as raw intelligence data and as such have not been subjected to any intermediate analysis, evaluation or collation. Interpretation and use of the information provided is the responsibility of the requestor.
- 3. (S) The protocol used for this session is detailed in the document, Grill Flame Protocol, AMSAA Applied Remote Viewing Protocol (S), undated.
- 4. (S) Following is a transcript of the viewer's impressions during the remote viewing session. At TAB A are drawings made by the remote viewer reference his impressions of the target site. At TAB B is target cueing information provided the remote viewer.

#### TRANSCRIPT

#### REMOTE VIEWING (RV) SESSION CC35

#43.5 This will be a remote viewing session (edited for security).

#### PAUSE

For the past few minutes you have been thinking, now, about the two individuals whose photographs you have. Relax, relax and concentrate and describe the area where these two individuals are. and concentrate and tell me about the area where these two individuals are.

#### PAUSE

Very confusing of images. #14

#43.5 Ok. Relax and tell me about them.

> First image was individual sitting in chair. I was behind him but I felt he wore glasses thick black rims. Although his hair was rather gray, that was black at one time. In front of him was a table, across the table sat another individual. I perceived the other person across this table as being not one of captives. Individual across the table was, I'm not sure, interrogator or quard, or something. This seemed to be in a setting not unlike..small apartment or motel type setting. After that image left I had an image of completely independent, and I know it's a different location, of a lot of microphones being set up as if ..um..oh, I don't know..microphones..um..like getting

That was totally independent vision. And following the one, I realized that I was only picking up on the one individual with the glasses. I then focused, or tried to focus on the other individual and I had a complete! different scene. It was very quick, and it was mostly just a viewing. I felt as though I was in the dark and it was cool..um..stone walls or masonry walls around me. Much like being in a basement, or something. Kind of

Ok. We're back on now. Let's go over the images you have and do the drawings and then we'll take a break and either start another session now or do one this afternoon....continued. ok.

#14 Yes.

Now this was odd, and it was very much like the ..the one session I had done before I had gone out to the coast. In that, I saw the individual from behind and I saw specifically his legs..his knees down there. My drawings will probably be rather crude. And, this, I felt was the individual concerned. Now this was the guy..and his back was to me. In fact, I didn't even see his head but for some reason my impression was that he had graying hair..uh..it was short hair, but, at one time he had black hair, and he had thick black rimmed glasses. He wore glasses. And..uh...trying to get everything else in focus is difficult but I know there was a table in front of him ..and, across this table sat another individual. Now, this individual...my impression..was not a captive. type individual. This was a... I don't know why I come up with this thing... for some reason..uh..either a quard or an interrogator or something like that...or an interviewer or....um..there was light in the area. Now this was the room...it was a room...but not a very large room. I had the feeling.....it was..if you had the feeling of being in a motel room, or something

The second one I was in a different area...you know...had a different atmosphere, but it may have been nearby to that area because it was...it just popped in and it popped out. And, I almost had the feeling of a.....stage..... I don't know why. Perhaps it was...but I definitely saw a bunch of microphones, with wires coming out and there was some more microphones standing here..... I'll label that page two...like if somebody was going

to get up and give or....that so...

No. But, it seemed that the atmosphere, ok..was..uh.. busy. Busy like it was being set up.

Third drawing. It's just..uh..I felt perhaps I was in a small cell like room. It's the only way I can describe it. Was steps...I felt there were steps that led to a doorway. I felt that I was at a lower level than the entrance or exit...and..uh..it was cool, dark. I didn't get much of any..any detail or anything. Uh..I felt as though I was somewhere here and the rest of it was around me, that way.

Now, this was when you were trying to focus on the second individual.

#14 Right.

#43.5 But you never saw him.

#14 Never saw him..per se. I felt more as if I was in his position.

#43.5 Uh..this first individual, if you were shown some photographs, do you think you could pick him out?

Uh..Well, let me describe him. Grayish hair, but at one time black. So it would be black with gray in it. Heavy dark glasses. He had kind of a squarish face. Not a round face, but rather square features to his face. Yes, it's possible I can pick him out.


- #14 No. No. Only that, for some reason, the..uh..

- #43.5 Ok. Well, good. We have it recorded and we'll let someone else worry about that.




