SUMMARY ANALYSIS

REMOTE VIEWING (RV) SESSION C 2

1. (S) This report provides documentation of a remote viewing session conducted for training purposes to enhance a remote viewer's demonstrated ability.

2. (S) There appears to be no target correlation in this session The remote viewer had difficulty developing his imagery. He was able to relax and concentrate but obviously did not focus on the designated target. The viewer said his images became very clear as the session progressed. The viewer did not have any feeling as to how well he had done. He feels he must have "gone"somewhere because his imagery was so clear. No explanation for lack of target correlation is apparent at this point. The viewer did state before the session that he was very hyper and not at all calm.

3. (S) The protocol used for this session id etailed in the document, Grill Flame Protocol, AMSAA Applied Remote Viewing Protocol (S), undated.

4. (S) Following is a transcript of the viewer's impressions during the remote viewing session. At TAB B is available target descriptive data.




