- #66: Now as you observe, describe the position in this area of Tom and Charlene. Watch them and describe their position in this area.
- #66: Report.
- #03: They seem to be in the swing.
- #66: Okay. I see by your, by observing your body motions that I would like to have you be more spontaneous, more rapid in your reporting. I see you processing information.
- #03: Um, um
- #66: Report it as opposed to processing.
- #03: Yes, the problem I see is I think I'm seeing something I know from before and that's--
- #66: That's fine, that's okay. Okay acquire the site again, relax and concentrate, acquire the site again. They're spending considerable time at the site, so we don't necessarily reinforce anything you've seen before, we can with something else.
