B-1A Justification for Programmed Expenses, CENTER LANE (PE 385128)

Justification: Foregoing requirements are necessary to provide for contractor's special support to operational activities and support of DA operational tasking (1f.), as well as personnel travel requirements in connection with that support (1a.).
