1. (S/CL-1/NOFORN/ORCON) Pursuant to the directives of CG, INSCOM, and in keeping with the Congressional Intelligence Committee FY 83 budget process, Army Special Access Project CENTER LANE is being implemented within the Security Support Detachment (SSD), 902d MI Group (MIG), with OPCON ADCSOPS-HUMINT and funded from the Security and Intelligence Activities (S&IA) Program. Spaces are presently established within various areas of INSCOM Headquarters, but not from HUMINT or any other GDIP funded activity.

2. (S/CL-1/NOFORN/ORCON) On 22 February 1983, CG INSCOM expressed his concern with personnel strength and its effect on the operational capabilities of Project CENTER LANE. He directed immediate action be initiated to selectively recruit quality personnel who would enhance the operational capabilities of Project CENTER LANE. In accordance with this directive, the Command Staff Psychologist assisted this office in identifying two personnel who subsequently volunteered for duty with Project CENTER LANE.
