MEMORANDUM FOR RECORD

SUBJECT: CENTER LANE Interview Summary - HU-1045/8310/01 (U)

1. (S/CL-3/NOFORN) On 181000 October 1983, source #01 was interviewed concerning the activities of an unidentified suspect between the hours of 0700 and 0830 on 24 July 1983. The project 8310 sponsor had provided a photograph of the suspect (see Incl 1).

2. (S/CL-3/NOFORN) For this interview source was shown the photograph provided by sponsor and directed to focus his attention on the suspect during the appropriate time. No other identifying data was provided to source. All other information was held for use during subsequent interviews.

3. (U) A transcript of the interview was prepared (see Incl 2).

4. (U) A DA Form 34l (Agent Report) was not prepared for the sponsor. Information related by source did not appear to be relevant to the sponsor's area of interest.

- #66: Describe the elements which make you call this a conference room, describe the furniture.
