That it should be BG Freeze's area of responsibility since the immediate application of the techniques obviously fall into the PI side of intelligence. BG Smith changed his mind and directed that COL Cary at Fort Meade, DCSCI, be briefed.

2. Briefed COL Cary on 3 Oct. He felt that the focal point should be selected from the Headquarters area at AHS. I agreed. COL Cary talked it over with BG Smith and persuaded him to make this an IAOPS responsibility. I was told to brief Mr Garrett, acting director of operations at AHS.

3. Mr Garrett was briefed on 3 Oct.

On 4 Oct Mr Garrett said that LTC Kane was the INSCOM Focal Point. 4.

5. On 5 Oct, a GF planning meeting was held at OACSI. Dr Targ (SRI), COL Deprospero (AMSAA), COL CApps and LTC Kane were among those attendig. The purpose of the meeting was to come to agreement on statements of work for proceeding on the Short Term GF approach. The following points were agreed to:
