2. Ref 1b advised of need to prepare for an updating of the ADCSOPS-HUMINT portion of ref 1a. I would like to use this opportunity to both update INSCOM Reg 10-2, and prepare a more detailed Mission Statement for the ADCSOPS-HUMINT including specific mission and functions of each Division/Office. Each Division/Office Chief should prepare and submit two mission and functions drafts:

a. Update of INSCOM Reg 10-2 for your activity. This should be a concise statement, stressing brevity and only essential functions based upon appropriate regulatory and statutory controls as well as verbal directives of ADCSOPS-HUMINT, DCSOPS and/or Command Group.

b. Detailed description of your activity's mission and functions for internal ADCSOPS-HUMINT use.

3. Attached is a working draft of our proposed portion of the HQ INSCOM ITA, including examples of current mission/functions statements. After each Division or Office listing of personnel are two mission/functions listings. The first is an extract from the portions of the current INSCOM Reg 10-2 most applicable to each element under our new structure. The second, annotated "More Specifically," is an extract from a master listing of ADCSOPS-HUMINT functions compiled earlier. The portions listed are again those most appropriate for your activity under our new structure.

4. In preparing both submissions, use the attached as starting points. Please identify any corrections and problem areas, i.e., functions that should be assigned another office and/or functions of another office that your activity should perform, etc.

5. Submissions are due NLT COB 15 May 80. Action Office is PPD, POC GW3 Mc Guire, X-6757.
