1. () TASKING: Interviewer was knowledgeable of the actual target, <u>purported to be</u>

Source was told only that this is a recurring requirement that has been tasked to other Remote Viewers in this unit in the past. Additionally, Source was provided encrypted coordinates of this site, as per Extended Remote Viewing protocols, to read 112170/018605, thus preventing inadvertent geographic cuing. Source was provided no other descriptive data pertaining to this site.

2. () SESSION: This was the first formal ERV session conducted between this Source and the Interviewer. Prior to the session, Source was provided a short instructional briefing on the type of terminology, procedures and techniques that would be utilized in this session. During the session, there were no reportable anomalies with the exception of a break in the session to permit a "comfort call" by Source. This interrupting necessitated the requirement for Source to "re-relax". Other than the unproductive consumption of limited time resource for each session, there did not appear to be a noticeable detriment to continued data reporting.

3. () SUMMARY:

a. () Initial reporting by Source did not closely correlate with known data pertaining to this site and in some cases the data was completely incongruent. This was especially evident in descriptions concerning, "sloping grass areas" around the site and an eventual description of a, "large, white, multi-faceted ball

on top of the roof", which may be more recognizable on a building near Source's unit which belongs to the US National Security Agency. It is not, however, known to exist at the target site. Additionally, Source either failed to observe or report the expected presence of military personnel at the facility and the very distinctive shape of the structure - triangular with connecting corridors resembling spokes running across the open area of the triangle. Source reported the building as rectangular which in terms of psychic reporting may have been a "convenient" description for the angular shape of the building. The lack of uniformed personnel, however, is curious since Source did report on personnel at the site whom she "positively" reported as being attired in civilian clothes and were, in her opinion, civilians. Again, Source's description may have been accurate if in fact, the only people Source chose to report on were civilians to the obvious exclusion of probable military personnel at the site.

b. () On the positive side, Source, after much confusion, eventually acquired a clear image of a central room which she equated to a, "war room". In this room, she reported the presence of maps, draping flags, symbolic plaques and an arrangement of furniture and fixtures which tended to confirm the presence of a large and important conference or meeting room, i.e., "five clocks on the wall and the U.S. clock is set at a different time than the time in this area", "long table with one chair at the end and the other chairs in the room arranged so that this chair becomes a focal point" and "maps hung on the walls".

3. () FEEDBACK: Due to the aforementioned interruption and the new and growing association between the Interviewer and the Source, it is believed that Source was unable to fully acquire the proper site. There appears to be some data which might indicate an end-of-session momentary acquisition of the proper target at the site, however, the data was only general in nature and will have to be confirmed during

future sessions with this Source concerning this target.
