1. (S/NF/SK) Tasking: Initiative/monthly followup.

- 2. (S/NF/SK) Session: Quite a bit of difficulty was experienced on the part of both monitor and source before target was acquired. Source P.I. of headache. Coordinates were created by monitor 5 minutes prior to start of session. Source was informed that monitor knew enough about the site to get her to the target. Source began session with what seemed to be a typical "joy ride". Subsequent cueing brought source to what monitor felt was the target area. Source was then told that the target was a "room" within the perceived structure. Source proceeded to perceive and describe several different rooms before acquiring one which monitor felt was reasonably similiar to what might be the target. Before terminating session, monitor informed source that she would be required to work this target again and that any artifice which she might create/imagine in order to aid in site recall would be useful.
- 3. (S/NF/SK) Summary: Target room is located in a populated, cold, dark city. The building is of newer construction than that of those around it but is, nevertheless, not outstanding in appearance. The building contains communications rooms, operations rooms with many people, a closed (SCIF-type) monitoring/code room, and a room which might be described as a "war room". This last room, without windows, is being used by a party of ten men, mostly military, who are involved in a briefing. The room is circular and furnished with swivel chairs; it is dim within the room so that slides may be projected as part of the briefing. The slides show the geographic locations of "SDI-type" weapon systems in Eastern Europe and the Middle East. [NOTE: Source states that "SDI" is signal vs AOL]. The briefer is discussing weapons

utilization and possible targets/effects. There is great concern present about the possibility of heretofore undetected locations (of these weapons systems) becoming known, a discovery which would have international repercussions. There are four locations in Eastern

Europe, but the present concern is primarily over systems in the Middle East because of the clandestine support connection.

4. (S/NF/SK) Feedback: Monitor told source that she had acquired the target and might have produced significant information.
