1. (S/NF/SK) Tasking: Original tasking data sheet attached. This source had worked the target four times previous to this session. Ops officer and monitor discussed several different approaches to this session; it was left to the monitor to decide upon a method of attack. Monitor created a Stage 6 worksheet (see attached) from which source began session.

2. (S/NF/SK) Session: Began by monitor instructing source to place a S6 matrix on the top of his page. Source was uncomfortable with this procedure, until he was informed (in response to his query) that he had already worked the site four times. Monitor then passed the Stage 6 worksheet to source and explained that the dark figure beneath the time line was symbolic of the site. Another S6 tool employed in this session was the use of a group of symbols (representing disparate elements of a project) placed within a circle (representing the "whole project"). When source objectified "things" as a general term for what this site was all about, monitor used it as a entree into the problem, (where, when and what).

3. (S/NF/SK) Summary: Site is located on flat, barren, northern terrain. It consists of many diverse elements; structures, things and activities, which are all related to or support a common military defense project. A large industrial-type facility is present on the site to support the project. There is a person here in charge who is very impatient by nature and frustrated at what he perceives to be the slow pace of progress on the project. (Refer to source S6 worksheet/time line): At the points (times) indicated on the time line, "sub-trials" of project (device) "sub-elements" were tested. In the near future, a "main trial phase" will be undertaken which will submit the device to limited operational testing. In this regard, source perceived that great care will be taken to prevent too great a

"signature". Monitor directed the source to place his pen on the word "signature" in an attempt to evoke more data. This produced associated ideas of: indicator, envelope, leakage, odd frequency, bandwidth, and color spectrum. Similarly, "indicator" evoked the ideas of 1) relevant/significant people gathering, 2) change in security patterns, 3) RF shielding, 4) equipment reference patterns, 5) power shifting, and 6) aircraft operation in vicinity.

A S5 of "trial phase" produced the following:

Objects - (source was instructed to turn his attention to attributes).

Attributes - highly technical, complex, metal, plastic, hot, cold, smooth, burnished, heavy duty, meticulously constructed, large, rounded, wired, irregularly shaped, angles, curved, dished, slanted, adjustable, electronic, powerful, black, dangerous, "soundy" (vs. noisy), highpitched, low-pitched, steady, clear, shiny, flat, intricate, microengineered, elliptical, and charged.

Subjects - evaluation, verification, assessment, calibration, matriculated, projection, power, "weapon", effects, radiating, emanations/emissions, demonstration, convincing, introducing, coercing, stifling, technology, physics, and alternating.

Topics - controlling, curiosity, anticipation, justification, satisfaction, and culmination.

Other perceptions of the device were that it requires high levels of voltage and amperage to accomplish its purpose. Also, the device is associated with a structure that is rounded, large, solid as well as a part that is rectangular. There is an old part and a new part. Levels and wings are present; as parts were added, aesthetics were not considered-functionality was the only consideration with regard to construction. There is "roof clutter"; functional things which may include RF radiators.

4. (S/NF/SK) Feedback: Monitor informed source that he has done a superb job.
