- 1. (S/NF/SK) Tasking: Original tasking data sheet attached. Tasking for this session derived from discussions between monitor and ops officer. Source would be directed to S6 pertinent site data (during operation of "device").
- 2. (S/NF/SK) Session: P.I. of cold. Source was allowed to review his previous session work and informed that this entire session would be devoted to S6 of his sketches. Monitor directed 003 to touch those points labeled "trials" on his last session's time line and to begin a S6 diagram of site from an overhead perspective. (Refer to sketches on pages 2a and 6a).
- 3. (S/NF/SK) Summary: Source immediately perceived "sub-levels" connected with site. In the "basement" located in the building labeled "A", is a massive piece of equipment (3-5 times taller than a man). This equipment manifests some sort of pulsing or rhythmic activity "in support of the main activity taking place" as well as associated ideas of "heat, flux, meters, dials, failsafe, redundant circuits, steady operation-does not fluctuate, as this would be disadvantageous to purposes". A conduit, carrying cables, pipes, etc., (with possibly a walkway on top), passes from this equipment into the (connected) building labeled "B". Here it undergoes what seems to be a "very symmetric" 90 degree curve, then passes through two areas, the second larger than the first, where people wait for "whatever" to arrive so that they may "do something to it". The conduit (?) then passes out of the building, and curves again, becoming what source describes as a long tunnel/passageway, above and below the surface, with things attached to the outside of it. See source sketch and description of the distant area (bottom of page 6a) into which this tunnel ends. Source commented that the site (located in a "Asian area") was "sealed", i.e., OPSEC was extraordinarily high.
