1. (S/NF/SK) Tasking: See original tasking data sheet, attached. Follow up of source's last session (09 Feb 87) intended to investigate key source-perceived areas of site.

2. (S/NF/SK) Session: Source was instructed to review his last session, place his pen on the large area (where "something is done to whatever passes through the area"), then to objectify his data in a S6 matrix. This same procedure was used to investigate the large "tunnel" which lead to an "impact area". A PI-inducing phone call brought the session to a premature end.

3. (S/NF/SK) Summary: Source sketched a long, strutted, curving structure which "conveys" something along it. This passes into the large, open area where measurements, diagnostics, and adjustments are performed on whatever is conveyed along it. Afterwards the conveyer seems to become a long, dark, tunnel; glinting, smooth and supported. Precision is important, structure (tunnel) must be precisely engineered, assembled, periodically adjusted and leveled; even expansion and contraction of components must be taken into account. There is a pulsing, rhythmic energetic feel, which accompanies the rapid movement of something very small, little, focused or highly concentrated, stings like a bullet, very dense and which imparts a "thwack" sound upon impact, accompanied by heat and fragmentation. The "objects" travel along sequentially, rather than en masse---importance stems from the object's speed rather than other factors. Other associated ideas are "very high tech" and "future applications".
