1. (S/NF/SK) INTERVIEWER TASKING: Determine the possibility of Iranian attacks against US Naval vessels and/or vessels of US Naval interest. To accomplish this tasking the Source is to be directed to view three separate "windows" in the future. These windows are the week of 6 September, the week of 13 September and the week of 20 September 1987. Each window is to be examined separately and in its entirety to determine Iranian intentions and actions during that reporting period. If an attack is perceived the Source is to be tasked to provide all relevant information pertaining to the attack.

2. (S/NF/SK) SOURCE TASKING: Prior to the session, Source was told that She was to re-acquire a previous signal line from a series of session She participated in within the last two weeks. She was specifically told re-acquire the site where She had been tasked to seek out specific weapons in an arid area and to determine intended use of those weapons. In this new mission, Source was advised that She was to return to the same area but not to be concerned with any specific type of weapons. In lieu of that Source was to determine the use of any weapons by forces in this area during time windows which She would be provided with in the actual session. In addition, Source was provided a set of encrypted coordinates, 279400/555141, as per Extended Remote Viewing (ERV) protocols, which were different than coordinate provided in the previously cited sessions signifying that this is, in fact, a separate mission.

3. (S/NF/SK) INCLEMENCIES: There were no unusual incidents or anomalies which may affected the data provided by Source during this session.

was prepared by Her and provided to the Interviewer within 24 hours after the session. The completeness of the typewritten summary has been compared to the Interviewer's notes and all changes, deletions and corrections have been verified as accurate and acceptable by the Interviewer. The information provided in the summary was found to be an accurate perception by the Source of the data produced during the session which was imprecise, ambiguous, confusing and in the opinion of the Interviewer, non-relevant to the actual targeting. Source was advised that the data provided during the session did not appear to be relevant to the actual targeting and an additional session would have to be conducted in an attempt to determine if the data provided during this session was a result of "missed target" or whether the Source was trying to report items of relevance which were not perceived or recognized by the Interviewer. Source understood that the data provided was inconclusive and in doubt following the session.

5. (S/NF/SK) COMMENTS: This was the initial session on this project utilizing this Source. By providing Her with the specific cues concerning Her previous sessions, it was hoped that the re-acquisition of the signal line would be expedited without any apparent loss of operational integrity. Source initially began reporting on an area which may have some unknown relevance but lacked any reference to a large body of water, (the Persian Gulf), and therefore She was "re-targeted" after which the large body of water became more apparent. From that point on, however, Source's data became disjointed and confusing and in some aspects tended to indicate attempts by Her to "make" the target some sort of research or testing "project". The Interviewer continually emphasized the words, "report on the significant events" but She continued to report on rather abstract and ambiguous concepts which could not be tied directly to the actual targeting.

I FIRST FELT THAT I WAS IN A LARGE, CIRCULAR AREA AND I COULD SEE MEN WORKING. IT SEEMED AS THOUGH THEY WERE MANEUVERING, CHANGING, AIMING, CHANGING. THERE WAS DEFINITELY A MOVEMENT.

THE AREA WAS FLAT WITH SMALL ROLLING HILLS. THE AREA WAS GREEN AND BROWN AND THERE WERE CROSSING ROADS. IT WAS A NATURAL SETTING IN A SOMEWHAT REMOTE LOCATION. THERE WERE NATURAL DIVISIONS IN THIS AREA.

I THEN HAD THE FEELING OF AN EXPANSION AND IT SEEMED AS THOUGH I WAS BLOCKED BY A LARGE DOOR OR A LARGE ROCK AND I COULD NOT MOVE IT OR GET PAST IT.

I THEN SENSED THAT THIS AREA WAS SWAMPY AND MUDDY. I COULD SEE MEN NEAR AN EMBANKMENT PILING UP DIRT OR WORKING WITH THE LAND. I ALSO SENSED THAT THERE WAS A LARGER BODY OF WATER NEARBY AND IT WAS BLUER AND PRETTIER. IT WAS BUSIER HERE AND I COULD SEE LARGE, HARD MAN-MADE TRIANGULAR SHAPES. THESE TRIANGLES WERE PLACED INSIDE EACH OTHER AND WHEN THEY WERE TAKEN DOWN, THEY WERE ROLLED DOWN.

1 SEPT - 6 SEPT: I COULD SEE FLICKERING LIGHTS BLINKING LOW. I COULD SEE A NICE VEHICLE GOING TO A MEETING. I THEN SENSED A PLACING OF NEW PEOPLE AND NEW THING SOMEWHERE. SOMETHING DIFFERENT IS BEING TRIED AND I THEN SENSED A DIFFERENT MODEL WILL BE USED FOR A NEW PROJECT. THEN I HAD A FEELING THAT

SOMETHING WILL BE DISPLAYED.

6 SEPT - 13 SEPT: I FELT THAT THERE WERE GROUP EFFORTS INVOLVED IN WATCHING OR GUARDING AN OPERATION. THE MEETING THAT WAS PLANNED WILL TAKE PLACE. I FELT THAT THERE WOULD BE AN OCCURRENCE THAT WILL TAKE PLACE. THIS INVOLVED MEN AND SCHEDULING AND PLANNING. THERE WILL BE A SENSE OF COMPLETENESS.
