IN THIS SESSION WE HAVE A SMALL GROUP OF PEOPLE WHO ARE CLIMBING OVER THE CREST OF A HILL. THERE IS SOME SORT OF OBJECT OR DEVICE LOCATED ON A HILL NEARBY. THE TERRAIN BETWEEN THESE TWO HILLS SEEMS RATHER FLAT AND IS GRASSY WITH LOW BUSHES/SHRUBS. 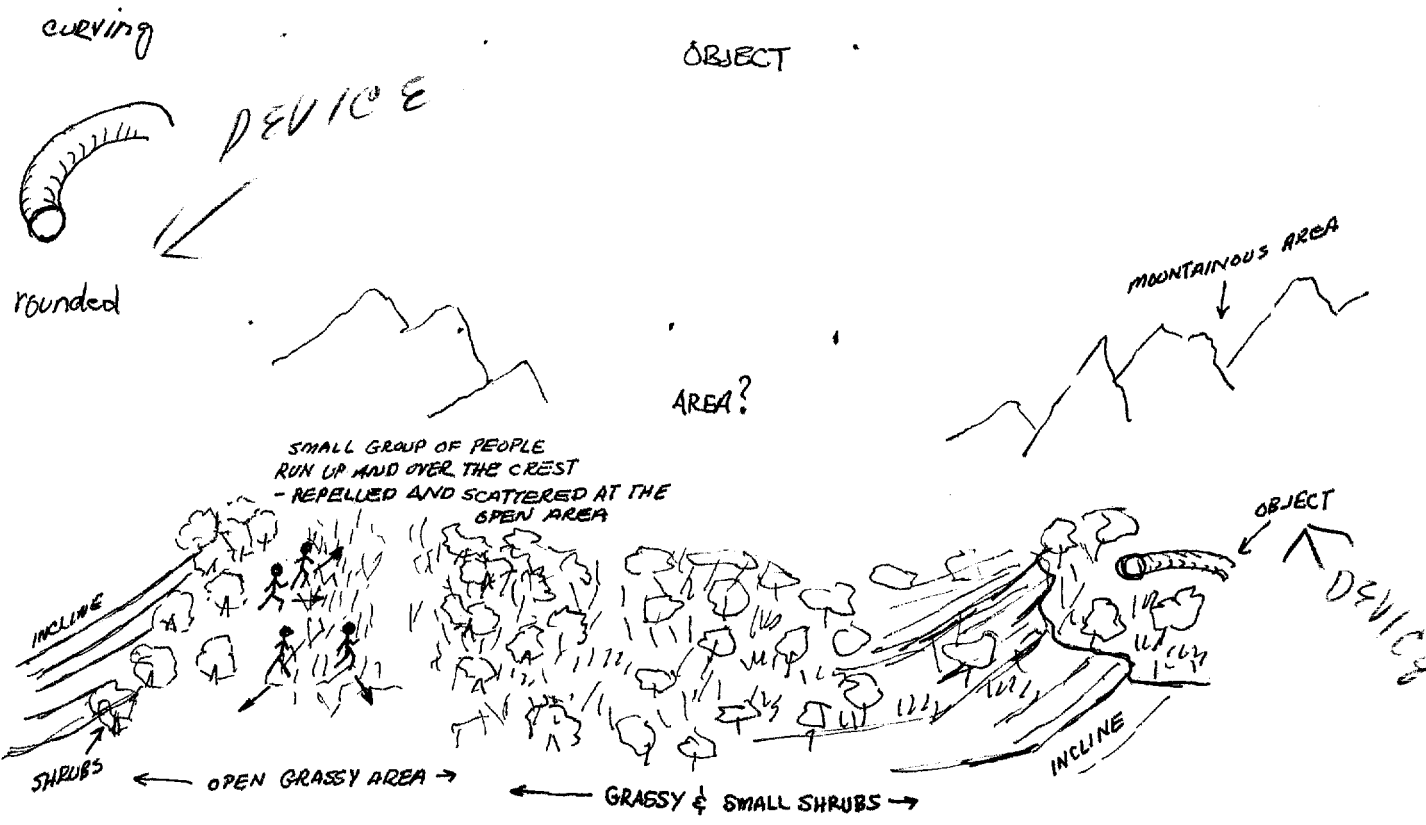
