1. (S/NF/SK) TASKING: On 23 April 1987, Source was provided a small opaque envelope which had been prepared for Him by hand lettering the words, "Project 8704 (the mission designator), across the front of the envelope. Additionally, the envelope had the words, "Tasking #1" written below the project number, indicating that this was the initial tasking on this project provided to Source. A small notation, "Suspense: CDB 24 April 1987", was lettered in the lower right hand corner of the face of the envelope. Sealed inside the envelope was a small sheet of notebook paper on which was written the following tasking: "Project 8704. 1st Tasking. Describe the purpose of the area located at 377566/752042. On 24 April 87, as indicated, Source provided the written results of His impressions on this tasking. After a review of these results, it was decided to provide Source with additional tasking ostensibly to be due on the following duty day. At Source's specific request, He was permitted to conduct an additional session on the same envelope (tasking) and on the same defy. Source was told orally that He was to, "view an area 6KM southwest of the area reported on earlier". By the end of the day, 24 April 1987, Source provided an additional written report on His impressions, which has also been included in this report. Source was not provided any feedback on His second set of impressions due to time constraints and prior out of State commitments by the Task Monitor. In each of the two tasking sessions included in this report, Source was told to keep the envelope in His possession and to provide a written summary of His Remote Viewing (RV) perceptions pertaining to the tasking sealed within the envelope on the suspense data indicated on that envelope. 2. (S/NF/SK) SESSIONS: Both sessions were conducted without the assistance, interviewing, or prompting by any other individuals. Source utilized a relaxation/isolation method similar to Extended Remote Viewing (ERV) protocols to conduct both sessions. Source did not report any unusual anomalies or incidents which may have influenced the data provided in His summaries.

3. (S/NF/SK) SUMMARIES:

a. (S/NF/SK) The following narratives, contained within quotation marks, are an abridged copy of Source's written impressions pertaining to the tasking provided to Him as explained above. These summaries have been editorialized, (as indicated), by the undersigned for clarity, grammar and structure. The actual unabridged summaries are maintained in the mission field dossier at this location along with all other material relevant to these taskings, i.e., the envelopes, tasking sheets, sketches, etc.

24 APRIL 1987, SUMMARY #1 - BEGIN SUMMARY: (The) area gray, overcast and gloomy. Site is a large building. There are many other large buildings around. The place where you enter the building is darker than it is outside. Inside (the) building it is quiet, almost hushed. There is a man on the ground floor. He is oriental or Mongolian. (He is) 45 to 55 (years of age), 5'6" (tall) and 155 pounds, (with) black hair. There is a large open room in (the) building. (The) room is multi-purpose (NFI). In the room there are five men sitting in a row like on a stage. Each one gets up and addresses a group and then sits down. It is almost like (Source underline) a board of directors addressing the salesmen and tell them what the company has come up with and where it is going. I look for a leader. One man on stage is very interesting. He is a "J" (a Myers-Briggs personality profile designator-Judgmental). He has his day planned down to five minute intervals, however he does not break projects down into milestones. Every project has only three parts; a beginning, a middle and a conclusion. He is thinking about making allowances in a mechanical sense. He is thinking that making (these) allowances is another word for "tolerances". He is also thinking about something that looks like a propeller. This place is concerned with holding, safeguarding, constructing and components. Things are built of components to be put together at some future date. This man who is (doing the) thinking reminds me of (a noted psychic researcher and scientist - name deleted intentionally by the Task Monitor) in a way. He is also thinking of light weight metals and alloys". END SUMMARY #1.

place (but at a) different time. (The) sun is shining but it is not hot. Maybe (it's) a spring or fall day. (There are) men working northeast of the "squat" (shaped) building complex. (These) men have shovels. There is a large deep hole in (the) ground. At times there is a crane here helping. (I perceive) a large cylindrical metal shape being placed in (the) ground. ([t]) looks like a giant spark plug. (It's) purpose (deals with) connecting and concealing. (I) move to the complex itself. (The) grounds are secluded in a way. There are people outside but there is not (a) freedom of movement (NFI). (The) squat building itself is "sealed off" (Source's quotation marks) in a way (NFI). (I) get a cacophony of impressions here. There is a large triangular shaped device with a blue ball which I take to be an accelerating device but without any raw data. There is a man here who is associated or is thinking about a place called "LA BE ON KA" (phonetic). In another area there are some animals (such as) chickens, pigs and what not. (The) building has a strange feel. I ask one person if he likes it here and he replies, "It's tolerable". People worry about what people in other geographic places are doing. There is a lot of insecurity here and a lack of specific as opposed to general direction. As I am leaving, I try to ascertain one of the purposes of this place. I get back energy but how that ties into pigs and chickens I do not know". END SUMMARY.

4. (S/NF/SK) OPS FEEDBACK: No further sessions pertaining to this target are planned utilizing this Source. His impressions are interesting and in some ways tend to confirm other data obtained from other Source's. No hard conclusions can be made from the information provided but considering the technique used, the results show great promise for increasing proficiency on the part of this Source in the SRV technique.
