- 1. (S/NF/SK) TASKING: This session was erroneously excluded from the SFR referenced above. The above cited SPR should be changed to reflect Session Numbers 02, 03. This document will report on Session Of only. The above cited reference to Mission Status: Closed in correct in that this mission is, as of the date of this report, now completed. The actual tasking for this mission can be found in the referenced SPR, cited above. All other protocols referenced in that SPR were in effect for this initial session. No other cuing or restrictions/quidance were provided to Source except to remind Him not to unseal the envelope and to provide His written results by the close of business on the date indicated on the envelope - 21 April 1987. Source was provided this tasking on 20 April 1987.
- 2. (S/NF/SK) SESSION: This session was conducted without the assistance, interviewing, or prompting by any other individuals. Source utilized a relaxation/isolation method similar to Extended Remote Viewing (ERV) protocols to conduct both sessions. Source did not report any unusual anomalies or incidents which may have influenced the data provided in His summary.
- 3. (S/NF/SK) SUMMARY: The following narrative, contained within quotation marks, is an abridged copy of Source's written impressions pertaining to the tasking provided to Him as explained above and in the cited SPR. This summary has been editorialized, (as indicated), by the undersigned for clarity, grammar and structure. The actual unabridged summary is maintained in the mission field dossier at this location along with all other material relevant to this tasking, i.e., the envelope, tasking sheets, sketches, etc.

21 APRIL 1987, BEGIN SUMMARY: "(The) area is misty, rainy, foggy and cool now...Moving from (the) first site to the second site (at a distance of) about 1/3 of the way between (the two) is an area of construction, RAW DATA - large piles of raw earth/dirt. This diet is a reddish color and is wet from mist and rain. Moving on, (I) come to the site which is a complex. Part of (the) complex is a low "L" shaped structure, probably a building and a large, older, squat (shaped) building of stone or brick. This complex is fenced or secured in some way. There is outside activity going on northwest and north of the squat building. My first impression is activity in a railroad switch(ing) yard but I am sure this an "AOL" from my last mission (NOTE: PROJECT "M" was Source's last mission and did indeed deal with a railyard). (The) relationship between (the) first and second site is very tight and interlocked in some areas and completely lacking in others. (It's) like two "Lego" blocks partially overlapped. I keep hovering at about 500 meters and concentrate on going to the part of the complex where I am supposed to go but I just keep hovering. I go down into (the) squat building for awhile (but I) do not see much of interest (after which) I go back to hovering. (All of a sudden) everything starts to shake. It is like being in an aircraft that is shaking itself apart. The ground is jumping up and down and rolling. I figure this is my imagination and I am not going to get anything else in this session so I (terminate the session)". EMD SUMMARY

4. (S/NF/SK) It is regrettable that the sessions got mixed up as they did, nevertheless, Source's impressions are the main point and as shown above, He appears to be on target but unable to successfully address and answer the intelligence question. This series was terminated in an attempt to gain some additional guidance from the actual customer as to the nature of this target. Perhaps if that information is forthcoming Source will be permitted to continue His efforts in an SRV mode to
