3. (S-SS) Results:

a. An object was accessed which relates in some unidentified manner with motion/energy. The object appears to be made of two major sections (see sketch, page 8):

1) A top section which is rounded, hollow with very thick walls, and contains some sort of two-part mechanism (see sketch, page 15). The outer surface of this top part has a black/silver color (ADL: similar to the surface appearance of tantalum metal), and has a dull, "machined" luster.

2) A bottom section which is squarish, very heavy, and appears to contain much more solid "inner workings".

b. Both sections of this object give an impression of "fake metal", almost like that of the metalized plastic used in many toys. Beginning impressions were the "doorknobbing" of some section of the mechanism which gave the AI of surprise that such an important mechanism would be made of such "cheap" feeling material.

✓ c. There was a very strong impression that there is a special person involved with this object, and that the working of the object is integrally tied to this person's specialized understanding. There were further impressions that the "specialized understanding" which

d. There were impressions that the operation of this object somehow involves a "splitting of energy paths", (AOL: as in a wilson cloud chamber). There were repeated impressions that an energy comes from this object which has a curved path.

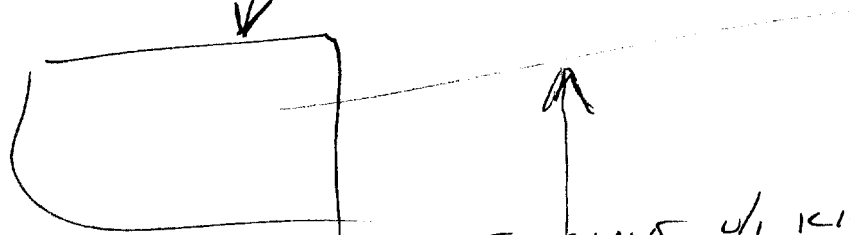
