1. (S/NF/SK) MISSION: Determine if the vessel known as [redacted] or [redacted] which left Honduras on 21 September 1988, was carrying drugs as suspected. If so, determine where on board the illegal drugs were stored. Determine how they were packaged and stored. Determine where they were unloaded and determine the final destination for the drugs.

2. (S/NF/SK) VIEWER TASKING: Encrypted coordinates 127880/79629.

3. (S/NF/SK) COMMENTS: Session was terminated early as viewer experienced difficulty acquiring the site and never progressed past stage 1. One reason for this difficulty may be that the requirements were written in present tense; the initial intent was for a predictive mode session. However, since O18 was not tasked until after the event had passed, the requirements were not valid in the form in which they were written. Another reason may be that the viewer was unconsciously confused about the requirements. This type of stage one difficulty has previously been noticed in sessions where the customer had additional unvoiced requirements/agendas, which causes confusion if the viewer picks up on them either consciously or unconsciously.
