SUMMARY OF INFORMATION

SG1A

The vessel identified as [redacted] is currently located in the immediate vicinity of the Tropic of Cancer at a position estimated as 20 degrees North and 172 degrees East.

It is loaded with contraband, in the form of drugs, in the bow area and amidships. The nature of the drugs was described as "crystals in bags."

SG1A

From its current location in the Tropic of Cancer, it will sail through an area known as "Murray's Fracture" <sup>(30N 150W)</sup> and "Kermit Roosevelt Seamount." <sup>(38N 142W)</sup> The [redacted] will discharge its illegal cargo at all three of these location. [redacted] will then sail for a final port-of-call located along the west coast of California in the vicinity of Cape Mendociano. <sup>(39N 126W)</sup> When it reaches the west coast of the California, the vessel will "be clean of (illegal) drugs."

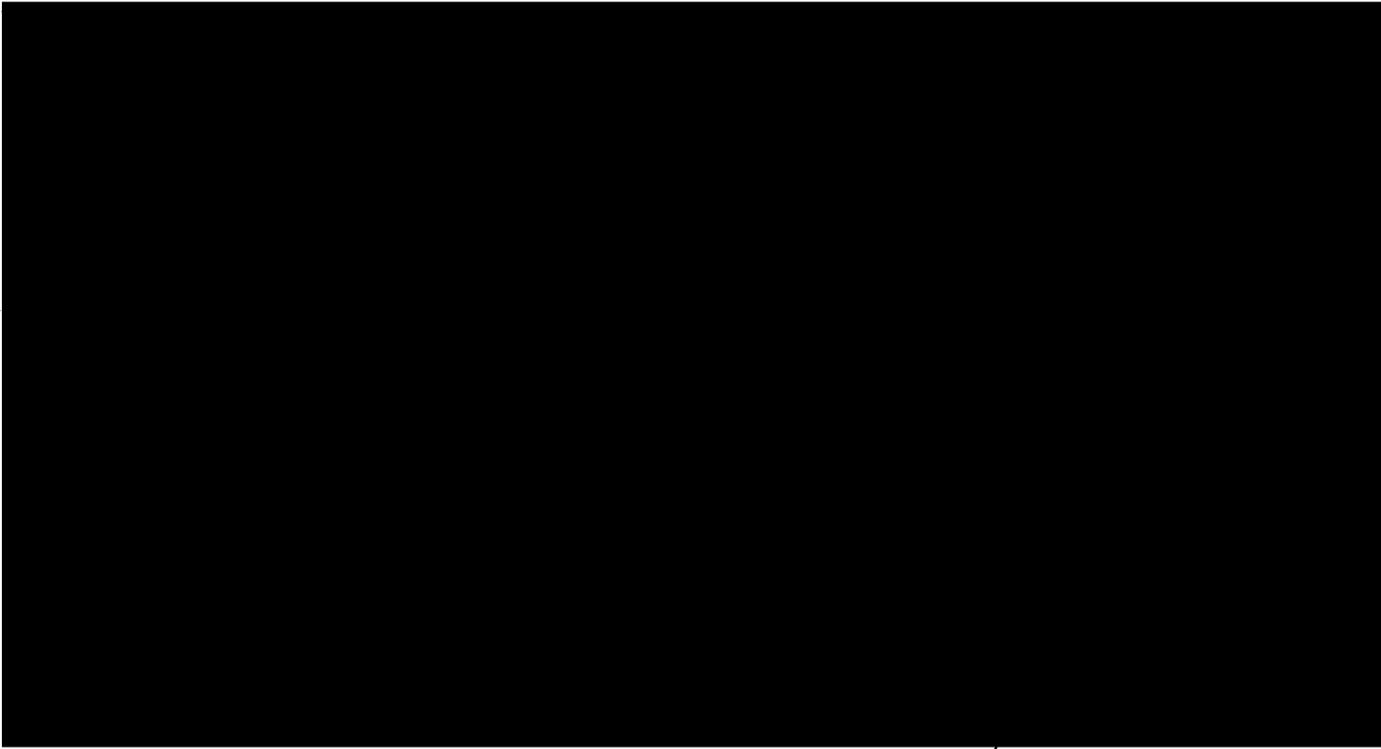
