SUMMARY OF INFORMATION

Building "A" (ENCLOSURE 1) is not of special intelligence interest. It functions in a normal and overt manner.

Building "B" (ENCLOSURE 2) is the area of special interest. Building "B" serves a "medical purpose." Activities conducted herein are done upon highly reluctant, fearful, so-called volunteers, almost against their will. The nature of the activity involves "hurting people" causing unfavorable reactions, shock against the body systems that prevent effective medical treatment. A prominent "bulbous reaction" by the body takes place as a result of the applied activity. Also, "small quantities of natural substances are produced" as a result of this activity.

An estimated seventy persons are involved in this process in Building "B". Either people are paid to do (submit) to this or there is a price on their heads (not further described).

Variations of the name "Kruells, Krueller, Kereurer" surfaced in connection with the "placement."

The activities in Building "B" are associated with the physical presence of blue "corridors/wings" where the activity is pursued in secrecy.

SUMMARY OF INFORMATION

Inside building B, there is a blue corridor (blue wings) area wherein some activities are hidden. The purpose of this building is medical. The activities involve hurting people by causing a bulbous reaction (sickness) on the bodies of unwilling people. Small quantities of a natural substance is produced at a time (kilometers). Approximately seventy people are aware of this process. There is a retention and reaction within the body, the application of which shocks (drugs) the system causing illness. These factors prevent medical treatment. A nose odor or smell is present. People are paid to do this or there is a price on the head of those it is done to (bounties). Phonetics concerning placement include Krueells, Krueeller, Kereurer.
