SUMMARY OF INFORMATION:

SG1A

1. (S/STD) Provide the true name of the person associated with the call sign [redacted] Again, this question has no exact meaning, so cannot produce an exact answer. There was, however, an impression of a "nordic-type" male with a very stocky build, short blond hair, and winning smile. He appears to be nicknamed "~~Ham~~". He was seen aboard ship in a narrow passageway, but his relationship to the callsign was not determinable.

2. (S/STD) Describe the vessel associated with the callsign [redacted] The vessel is very ~~large~~. The colors appeared to be mainly black and/or ~~very dark grey~~, and there appeared to be the very light beginnings of rust on the sides. No further information was gained.

3. (S/STD) Determine the current location of the vessel: (Time: ~~0945 hrs~~ ~~Local, 29 MAR 90~~) Repeated attempts to locate the vessel on a map produced ~~no results~~. The ship, however, is docked in a port which is on the southern side of a land mass with open sea to the southeast (see map sketch, Fig. 1). There is an oriental feeling to this city.

4. (S/STD) Determine the destination(s) of the illegal drugs: Again, attempts with a map failed, but the destination is a port which is located across a bay or narrow gulf from other land. Open sea is to the south (see

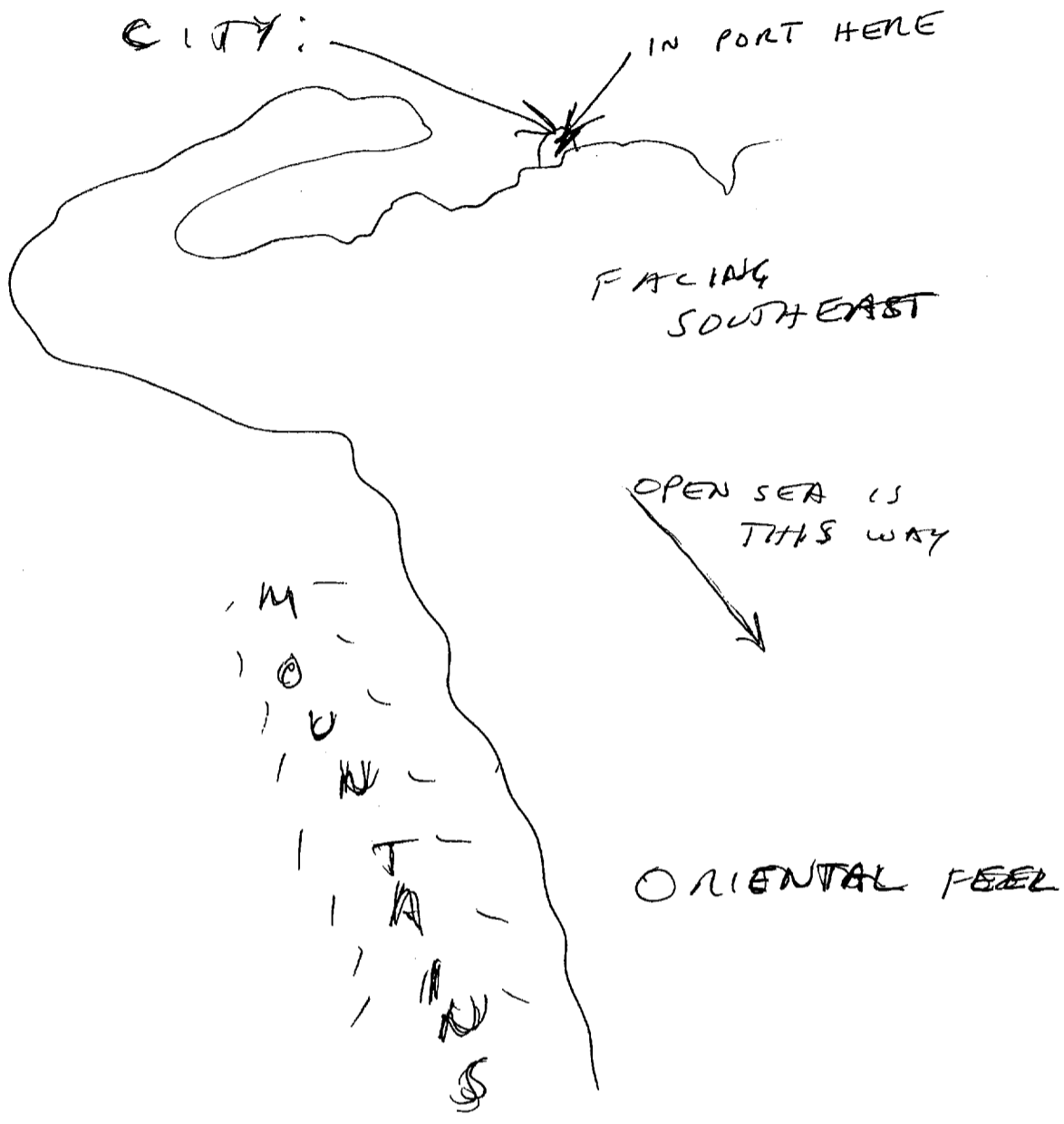
