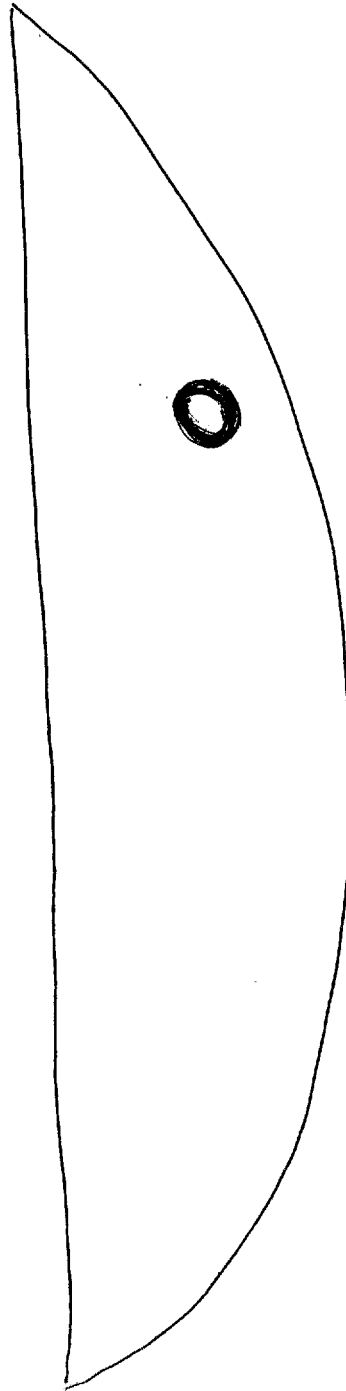
SUMMARY OF INFORMATION
