- The target vessel can be located at geographical coordinates  $21^{\circ}$  N and  $73^{\circ}$  W.
- The vessel will sail in a northern direction and off-load its contraband at geographical coordinates  $27^{\circ}$  N and  $63^{\circ}$  W. This off-loading may take place within 3-5 days.
- The contraband will be off-loaded onto two smaller vessels.
- Ultimate destination of contraband cannot be determined at this time.
