They are not in a structure or vessel but in a chamber down below and surrounded by the colors silver, white, and red. The drugs are packaged in plastic and paper. There are a lot of drugs here which are ready to be put in smaller packages for distribution. A crew witnessed the loading/unloading of the drugs.
