RESPONSE: CURRENT (21 1100L MAY 90) LOCATION OF
The vessel is NORTH OF ARJUA AT 14° 56' N 70° W with a heading of 338 degrees.

2. Describe the nature of the ^{illegal} drugs aboard ship, if any.

RESPONSE: The vessel is currently carrying 8-10 Kilograms of cocaine

3. How are the illegal drugs wrapped; and, where are they stored aboard ship?

RESPONSE: The cocaine is wrapped in several layers of ⁰⁰waterproof material and in a "metal bubble" welded in place on the port-side of the vessel near the bow several feet below the waterline.

4. Where will the illegal drugs be off-loaded transferred.

RESPONSE: In approximately 8 days (29 May?) between 2100-2400L hours at 18° N 74° 50' W (WEST OF HAITI).

5. Where in the US, will the illegal drugs be offloaded? SOUTH FLORIDA
